- Wendy Root Askew, District 4 Supervisor Provided her background history and was recently elected to the seat of District 4 Supervisor; introduced her team as Yuri Anderson, Jenny McAdams and Eric Mora and have been active on social media sharing information on County updates and Covid information. County office is virtual due to Covid. Committee assignments for District 4 for this year include the budget committee, alternative energy and environment committee, human resources, Covid Ad-hoc communication committee, central coast community energy, central California alliance for health, Monterey Bay Unified Air Pollution Control District, MRWMD, and TAMC. County is planning for mass distribution of the Covid vaccine and testing sites still remain available in Seaside and Monterey.
- Brian McCarthy Announced 2 Odor meetings taking place. On Friday, January 22nd at 9:00am hosted by Monterey Regional Waste Management District and then on Wednesday, January 27th at 6:30 PM the City will host; Commented on the compost fire that broke out this weekend; Sent an email to council last week on tobacco retail licensing and Marina still has not taken any action in moving our city in a different direction. The American Lung Association give Marina an overall grade of F in each one of 3 sub areas measured (smoke free air, smoke free housing, sales of tobacco products to minors) which gives us zero bonus points for any efforts the city has taken with regard to emerging issues. Hopes council will look at tobacco retailing licensing as a first step and help protect our kids in the future.
- Audra Walton Made comments on the Inauguration and thanked everyone who served under the past administration; Monterey County Black Caucus will have its first black talent show on February 6th at 6:00PM via Zoom. Monterey County Black Caucus has a mission to heal and empower the black community by cultivating leadership, providing a safe place for black residents to unwrap and reflect by advocating for equity and inspiring culture through arts and community development. We heal through arts, music, colors, dancing, laughing and most of all we heal through unity. - Mike Owen Submitted an 8-page summary of the Site and Exploration Committee from 2009 and was given assurances that that would be passed on to the Recreation and Cultural Services Commission and also expressed a request to do a presentation or at least to be able to speak a little bit more that 4-minutes so I would appreciate some feedback on that. Commented on the February 3rd Recreation Commission meeting would be a once and done deal and hoping that's not the case and that due deliberation is given and have February 3rd meeting as a work study and not just something that's expected to have a decision based on very summary exploration. Happy that members got to look at the sites which I had recommended last year but I had only mentioned MST, Vince DiMaggio and in back of the Library so I'm not sure any of the other sites were looked at or what kind of criteria people used to judge the sites which is supposed to be determined by the commission.
- Liesbeth Visscher –would like to encourage everyone to visit Citizens for Just Water website: www.citizensforjustwater.org to learn about the threat to our water. This is the best way for us to reach you in the future when or if Cal-Am's proposed Slant Well project will be back on the Coastal Commission's agenda we again will need lots of help. Please stay tuned. Thank you, council for all that you're doing for our city.
- Nancy Littlejohn Commented on the conditions of the city streets in Marina particularly Andrew
 Circle. Noted that several children have has spills on that street resulting in bruises, scrapes, cuts
 etc.... Neighbors have expressed concerns about the condition. This street is poorly maintained
 and knows that Council is looking at the agenda for the next few months and would request that the

street allocation of repairs in Marina that at least we can look at possibly seeing when we can get Andrew Circle repaired, thank you.

- Grace Silva-Santella Inquired as to what the format will be for the February 3rd Recreation Commission meeting, what the involvement of the public will be and if the expect to make a decision at that meeting. Are they looking at the MLK statue by itself or is there an agenda item to be including all other statues that city has in storage?
- Paul Beery Provided Marina Equestrian Center updates and thanked the Marina community for coming out to the Equestrian Center to enjoy the Winter Wonderland and look forward to future events; New programs MEC partnered with the Monterey Bay Equestrian Center to offer an expanded trail riding program. They have 8 horses boarded at the facility and they offer guided trail rides through the Fort Ord Dunes State Park and other trails in and around Marina. We've expanded the lesson riding program in anticipation of the partnership with CSUMB and the equestrian team. We've added a full-time riding instructor specializing in western riding. The MEA is taking efforts to response to the fires in Santa Cruz county and have reached out to the animal services and animal social media outlets to let them know the Equestrian Center is open and here to help.
- Mayor Pro-Tem Biala Read responses from City Attorney on her questions relating to the public role with the entire council and the Brown Act. Spoke about the development of signs courteous of the city's Covid-19 Enforcement for the local businesses to place on their doors/window saying, "We wear masks to protect YOU...please wear masks to protect US". Thanked the City for doing this public service announcement and thank you to all the businesses who agreed to hang these up in their place of business.
- Council Member Burnett Wanted to see if there was any interest on the part of the Council possible hosting sometime in April or earlier a memorial or moment of silence for the victim of the Covid-19 deaths that have taken place in Marina and throughout the Nation. Commented on the inauguration and peaceful transfer of power to a new administration and that this is signaling a new time, a new era in our country. Two weeks ago, a riotous and Sidious mob used every effort they could to take away, to defer our democracy and I think 1/6 is a date that shall live infamy in the world. Encouraged everyone that if you hear anyone celebrating their activities in Washington on 1/6 that you reject such claims, that you denounce such celebration and call them out for what they truly were, the Traitors X to betray our country.
- Brian McMinn, PW Director Announced on January 27, 2021 at 6:30 p.m. there will be a Zoom meeting on the Odors in Marina. Participants will be the County Environmental Health, Air District, Waste Management District, Monterey One Water, Cal-Recycle, the Ag Community.
- Council Member Medina Dirksen Commented on the events at the Capital and thanked all the
 attendees tonight for participating. Thanked the volunteers at the Food Drives for helping out the
 Thomas Carman Food Bank since they were unable to participate this last round. Shoutout to one
 of Marina's firefighters, Anthony Prado who is part of the Strike Team who went down the LA
 help with the overflow of Covid patients, so thank you to him, his family and colleagues for
 covering shifts.
- Tina Nieto, Police Chief Thanked Mayor Pro-Tem for the work that her committee has done to reduce the Covid vaccinations. Since the Covid outbreak we've really had a community that's been cooperative with wearing masks and doing the right thing and following the Covid protocols. Spoke about Covid fatigue and her department getting calls to back up the Covid Enforcement Officer to because people are refusing to wear masks in public. Wanted the public to know that you can be sited for that and that we know you're tired and it's affecting everybody, but we understand. We want to ask for your continued cooperation in helping us all be safer.

- Mayor Delgado Thanked Haley and Julianna for putting on an event, a drive-in movie at in Marina that will be free for the first 30-cars that register on February 27th at the Veterans Transition Center; Thanked volunteers for the litter pickup events and graffiti removal; Shoutout to Glenn Woodsen for Marina Holiday Lights.

DELGADO/BURNETT: WE APPROVE THE FIRST READING BY TITLE ONLY AND WAIVING FURTHER READING ORDINANCE 2021-REPEALING EXISTING CHAPTER 5.28 OF TITLE 5, ARTICLE II OF THE MUNICIPAL CODE IN ITS ENTIRETY AND REPLACING IT WITH A NEW CHAPTER 5.28 ENTITLED "BINGO." 5-0-0-0 Motion Passes by Roll Call Vote

b. City Council open a public hearing and take testimony from the public and consider Planning Commission recommendation to adopt a Resolution approving a Combined Development Permit consisting of 1) a Lot Line Adjustment; 2) Conditional Use Permit for residential density over 25 units per acre; 3) 35% Density Bonus and Project Incentives to allow an increase in allowable height from 42 feet and three stories to 54 feet and four stories and a reduction in parking with associated waivers for a reduction in front yard setback and a reduction in covered parking; 4) Affordable/Inclusionary Housing Plan for 14 on-site affordable housing

units; 5) Tree Removal Permit for the removal of nine (9) trees; 6) a Sign Permit; and 7) Site and Architectural Design Review for the Site Plan, Elevations and Landscape Plan to allow the development of a new four-story, 94-unit apartment complex at 3298 Del Monte Boulevard (APNs 032-031-001 and 032-031-003).

Council Questions: Will these be rentals or Condos co-ops? Why is it not combined into one lot for this project as opposed to two separate lots? Which lot has the access? Are the parking stalls divided between the lots and are they proportionate to the number of units on each lot? Is it feasible then if they're doing it for financing that upon completion of the building that the two lots can be combined into one? Do you see a need for further cooperation given that we have a 5 meeting limit, do you see that the Planning Commission and City Council can combine our efforts in some way that would help streamline but at the same time make sure nothing gets dropped through the cracks? With the 60-day window with action to be taken otherwise it would be an automatic approval, if so, with us sitting here is that considered taking action? On the traffic study there was mentioned 500 trips, what constitutes a "trip" and did they consider how many "trips" are on Del Monte any given day? How many entry/exit points are there for this project? Visitor Parking, Bik Lanes and limited handicap parking? Does the city have a ladder truck to accommodate a four-story building and is there fire lanes? Sprinkler system installation? Parking versus bonus density?
