I know that Councilmember Burnett served on the redistricting committees for the county Monterey, so you have people in the community that have experienced. I'm very glad I think what I'm seeing in there, is that there is a, it looks like perhaps a web based online tool that the public can use. It was very clugie the last time when people had to do this. #### **Public Comments:**

- Bran Imamura Brad Imamura But with regard to your timeline. My two words are good luck. People who serve on the current Council have not served in municipal government. I know from experience in working my whole career and municipal government knowing how things move, having to hire you know all these consultants and whatever. But again, good luck on this. With regard to the last item, Systemic Racism, totally speechless. I believe Councilmember Christina. Medina Dirksen indicated that the Marina was the 8<sup>th</sup> most diverse city in the United States. So, that's, amazing to me so we have a systemic racism problem, I'm just without words. But anyway, Good night.
- Nancy Amadeo Number one, the number of parks that are on the list, and building a park and
  maintaining a park and servicing a park are three very different things. One of them you hire a
  contractor, and they build the park but the other two, you have to have permanent staff to operate a
  park and permanent staff to maintain the park, and that needs to be considered when you think
  about the two year budget. I'm also very concerned about the issue of the general plan. The

downtown specific plan, and the Cypress Knowles which would also be a specific plan. One of the things that a planning commission has to do is find that your plan is consistent with the general plan. Well if your general plan is not completed your new general plan, then you use the very outdated from the year 2000 in order to find consistency. There's been a lot of ups and downs where Cypress Knolls is concerned, but I'm not sure that you want to base your RFP for Cypress Knolls on a general plan that is over 21 years old. I think that it would be inappropriate to move forward with Cypress Knolls. You're putting an awful lot on staff's plate, and you're trying to do it in a very narrow timeline. Recommend that you whittle down your list to things that can actually be accomplished over the next two to three years. Thank you

- Karen Andersen Suddenly we have 10 new items, which probably are related to items on the consolidated list, which has had a very consistent numbering process. So, the numbers on the consolidated list, even as they moved around here and there, up and down, and priorities the numbers stayed the same and so, this new list of 10 items, and now 12 items aren't numbered the same way. So, this is, this is confusing to me and I might not be the only one. The mandatory urgent projects funding sources list has timeframes on it. And so is there is there a very strong correlation between those timeframes and the time frames on the the general fund projects list, are they correlated to this list that is this new list of 10 or 12 items? And then, by adding items 11 and 12 it's as if we're jumping back into the prioritization project that's been going on for the past six months and that people have participated in, and I'm just wanting to put out there that for me. This is very confusing, and I've been somewhat involved in this process for a while, so I'm not really excited about what's happening here tonight and so, I would vote against it personally. So, thank you very much.
- Mike Owen It's encouraging to hear the City Manager, talked about the different consultants or the additional consultants that he's hiring for individual specific projects. Earlier in the year, I had an occasion to bring up the question about the senior planner vacancy and the explanation I remember from the city manager was that, although it's been vacant for a year or something like that he was still pretty discouraged about the prospects of getting some qualified applicant just simply because of the supply and demand restrictions that were out there. So, my question is, is that position still vacant? And then, considering the Community Development Director, which is at an even higher level I'm just wondering what the prospects would be for fulfilling or getting qualified applicants for that position. Can you do a general plan without permanent staff? Can you hire consultants to come up with general plans? If there happens to be the same prevailing restrictions, as far as finding qualified applicants that are out there, and the community development directors position is vacant say for until next year, then there's still time for the new person coming in to get up to speed. Thinks you're being really a bit optimistic about the deadlines. Thank you
- Brian McCarthy Echo concerns that it sounds like council may still be trying to bite off more than can be chewed. Particularly concerned about the general plan and Cypress Knolls. Worried that without a robust general plan that Cypress Knolls is going to be written based off an old general plan and conversely that the general plan will be written to accommodate, what we want to see in Cypress Knolls and not sure that it should be done in that way. I think the general plan should be written generally in terms of what is best for the city as a whole and not for one particular project. Encourage council to look at some new general plans that are coming out from cities throughout the state, many of them are very robust, and go through a long process that demands strong public comment for a long period of time. To do a general plan right, it's going to take a lot of time and effort. Not sure that the city should be taking on other development projects in addition to the general plan, or even concurrently with the general plan. Thank you so much.
