- Layne Long, City Manager Provided two recreation announcements related to July 4th events. Spoke about the city issued a Certificate of Participation which essentially, is a bond for our 2022 Traffic Transportation Infrastructure here in the city for \$11.5 million dollar that we will pledge our measure X money. We're getting a lump sum of cash up front that we're moving forward with a massive reconstruction of failing roads and getting all our roads up to the condition we want that process will happen over the next couple of years. Announced that our August 2nd Council meeting will be cancelled and rescheduled due to Public Safety Night Out taking place on August 2nd. Announced that the city has hired independent public opinion research firm will be sending out surveys to on a random basis to our citizens that to get feedback on key issues and identify priorities of the city and the community.
- Doug McCoun, Fire Chief Announced Safe and Sane Fireworks will begin to be sold starting June 28th and took a moment to talk about the differences between Safe and Sane and Illegal fireworks. Asked if somebody observes illegal fireworks being used and there's no injuries to call the non-emergency dispatch number 831-384-7575 and they will send out the appropriate response for right non-emergency call. Spoke about the fines: the first offenses \$333.92 cents. The second offense, which is \$533 dollars, and a third is over a \$1,000.

- Council Member Medina Dirksen Commented on that Friends of the Marina Library had a
 wonderful event the Dad's Read featuring Nick Kite. Spoke about the Marina Teen Center
 membership and summer activities. Commented on Monterey County Gives program. Attended
 Seaside's Juneteenth celebration. Spoke about Veterans Standdown event at the Monterey
 Fairground. Attended the Hospitality Associations luncheon on June 10th.
- Council Member Berkley Spoke about the warm weather and the effects it has on our pets. Announced that at 4:00pm tomorrow will be an official Pride Flag raising ceremony at the flagpole at City Hall
- Mayor Delgado Commented on the Police Chief Nieto's November Sheriff runoff. Commented on the youth summer programs and Junior Giants and Marina Youth Soccer. Commented on the Pump Track groundbreaking and asked when the Pump track might be opened. Spoke about the Handcars that have started to show up for the summer and asked for an update on the lease with TAMC. Announced there will be cleanup events happening in July. On July 3rd from 9:30 to 1230 along Salinas Avenue & Carmel Ave Road; on July 10th at Salinas Avenue & Reservation Road from 9:30-12:30. Commented on graffiti removal by retired Marina Police Commander Robert Nolan along some residential areas along Patton Parkway and our downtown area.
- Mayor Pro Tem Biala Asked City Manager to provide an update/memo on all the construction projects going throughout the city in the meeting packet just to let the public know what's going on.
- Mike Owen Spoke re-engagement of city commissions and asked if the City Manager could place this on a future agenda in August.
- Brian McCarthy Commented on the need for tobacco control and the Blue Zone project and noted other cities banning flavored tobacco and vapes. Played a short video clip on "the filter" and smoker safety.
- Jeff Markham Commented on the police department apprehending an individual who had stolen a bicycle and returning it to the owner; spoke about a fire at Patton and how quick our fire department put it out.
- Tommy Bolea Commented on buying locally but also having to travel outside of Marina due to items not being sold here or certain businesses not being here. Spoke about a virtual city and purchasing online. Commented on the developments taking place throughout the city.

Council Member Medina Dirksen had questions for 8f(2). Asked how long do General Plans last? Are there plans for annexation of East Garrison?

Mayor Pro Tem Biala had a comment for 8f(2).

9. PUBLIC HEARINGS:

a. City Council open a public hearing and consider adopting Resolution No, 2022-, approving the assignment of the Development Agreement related to the Marina Station Project to 3rd Millennium Partners; and read by title only and approve the first reading of Ordinance No. 2022-, approving the first amendment to the development agreement related to the Marina Station Project. *Continued to July 19*, 2022

Council Questions: Clarification on "project has the capacity"? did you mean water? Clarification, when you mentioned the vernal Ponds testing, did you say it was limited to the city? Will city be notified if testing will be done on the vernal ponds? Are the developers frozen in time with 2008 our rules and standards and are they exempt also from State laws, such as SB 9 or any others? If we were to pass our General Plan before this goes into effect would the developer still be in the 2008 mode to would they be exempt for the new standards? Will a traffic study be completed, and will it be done by the developer? Unlike The Dunes and Sea Haven, this property was never under FORA and had never been Government property, this was a pretty private land sale to now another private owner, correct? The affordable housing agreements are part of our general plan, and that's our only in on this project that it's within the city's spirit influence, so they have to develop this according to this development agreement in our existing general plan, correct? Under the recitals of Exhibit A, #11, this development agreement there will be no other circumstances that would allow for modification outside of these recitals, correct? With a possible recession coming giving them an extension to 2036 would be sufficient buffer given what's happened in the past, correct? This development agreement reads pretty much like the agreements we've had with the Dune and Sa Haven projects, can we anticipate similar outcomes/issues that we've had with the other two? What is the open-space acreage for the entire project? It is all open to the public? The conservation and easements would be part of the Sierra Club lawsuit that generated this outcome, correct? Can we ask in the amendment that the city receive copies of any monitoring and reports on the vernal ponds? If we do not grant an extension does this this project come to a halt? Does a tentative map have an expiration date, or does it go forever? If we didn't approve the amendment, what would they do regarding the final tentative map? How many maps version are there? Why is it called Marine Station? Where was this transit station to be located in the project? So, if we wanted that area that's going to be redesigned as far as the uses residential

commercial retail and we approve everything tonight it seems like we lose a lot of leverage because we can't drastically alter what they propose to do there, correct? So, what we're seeing now has not been approved it hasn't been publicly digested, it's a change from the marine station plan is that correct? Can we see a digestible easy to understand map of the approved park locations and distribution versus the current proposed post Sierra Club settlement distribution and locations of parks? What what's say will we have in the mix of for sale versus rental below market-rate? Has the planning Commission or the City Council ever digested and understood how the Sierra Club settlement agreement with the developers or the property owners back in 2008 impacted our vernal pools and what our give and take was? Have we ever, as a city understood and digested, how that settlement affected changed this project? When can we address evasive grass/weeds and the sand dunes? Coastal access, with the plans today before us now, how do people get from Marina Station development, let's say residential to the coast to the road that goes under the highway across Lapis Road to the beach? Exhibit B, Section 2.4.7 Rent and Price Controls, last paragraph; if the city should pass a rent stabilization, or some form of rent control, it could never apply to this property, correct? Is the wording in that last paragraph negotiable? Are we limited to how many meetings we can have between the Council and Planning Commission to approve this? Is there any rush that we have to address this, this evening? Is it possible to have the inclusionary homes built first?

Mayor opened the Public Hearing for Public Comments:

- Karen Andersen Commented on the developers accidently grading away environmentally sensitive plants and asked what are all of your plans to prevent this from happening with the vernal pools and anything else that's environmentally sensitive in this development?
- Tommy Bolea Asked if this was a Council meeting or a Planning Commission meeting due to the topics being discussed. Asked what is the percentage of renters in Marina? How many rentals will be included in this project? Low income, low market housing agreements were mentioned and asked how do those terms exactly work? Asked about the phasing of the development.
- PK Diffenbaugh Appreciates the level of scrutiny and review of that council is doing to ensure
 that this development is the right decision for the city of Marina. Shared perspective from the
 school perspective how difficult it is for our families and for our teachers to live on the Peninsula.
 Shared the number of current students who are homeless and the need to have affordable lowincome housing. Spoke about the closing of 3 schools.
- Denise Turley Asked to hear from Karen Tiedemann on the RHNA numbers and how this project will affect them.
- Jeffrey Markham Asked Council to take time to review this project and not take any action tonight. There's a lot of stuff grandfathered into this and has been on the back burner for a long time and it's a complicated issue. Did not appreciate the tone the developer took with our City Council and our staff tonight.
- Paula Pelot Commented on the different developments that have taken place over the last 25years and the fact that new residents would like to have an input into future changes. Noted that
 with this amendment that now is the time to make changes and see if it conforms to the vision and
 the values of this city. You are within your rights, and it is your responsibility to ask these
 questions and to evaluate this project.
- Brian McCarthy Would like to hear a more candid conversation from both the developer and the financial experts that might educate us on likely outcomes depending on if the economy does right or if the bottom falls out again like it did in 2008. Asked for clarification on rent control provisions, little confusing. Questions council brought up are valid and should be discussed.
