Council Member Medina Dirksen had questions for agenda item 8a, asked why PG&E payments were so high; has the city considered solar and asked about the AP's being itemized by department.

9. PUBLIC HEARINGS:

a. City Council Open a public hearing, take public testimony, and consider adopting **Resolution No. 2022-119**, determining that the proposed Tentative Map amendment is consistent with the certified EIR (SCH No. 2004091167) and adopted University Villages Specific Plan (now the Dunes on Monterey Bay), approving an amendment to the Tentative Subdivision Map originally approved in 2005 (Resolution 2005-131) as amended (Resolution No. 2008-209), and approving Tree Removal Permits for Phase 2 West and Phase 3 Residential of the Specific Plan, as unanimously recommended by the Planning Commission of the City of Marina.

Council Questions on staff presentation: There was mention of about there were 7 trees inadvertently removed. Were those by accident, or was that on purpose? Staff report indicates no fiscal impact, and in my reading of this the number of residential lots was reduced by 20 units does that not impact the tax that the city would ultimately receive? So, the specific plan does, does indicate the total number of units and the anchorage devoted to housing, correct? So this revision to the map continues that call out by the specific plan, with no major change or reduction or expansion of those initially and agreed upon designs?

Council Questions on Proponents presentation: The \$45 million of impact fees and post FORA fees, is that related to phase 3 or the whole Dunes project? How much of it is phase 3 that we're talking about tonight? The \$20,000 for parks is that the entire project and it's 4.6 million for phase 3 right? Would you consider these payments part of your expenses overall? Phase 3 - of the 19 trees that are going to be kept out of the 202 that exist today are they in the linear part or are they in the areas where they're shown as homes going in? Of the 175 trees, why couldn't we have relocated some of the iconic trees to get them out of harm's way during construction of these phases, like we did in the past? Do you have any approximation of how many of the 202 trees that are going to be cut in the residential area are in good or fair condition, and able to be relocated if the desire was there? What will the parking look like if scaling down you plan? Is there adequate turnaround for fire truck? When talking about affordable housing, can you tell me how that plays into the Terracina Apartments? Is the Terracina Apartments project prevailing wage? Will this project have any view sheds and water saving features, such as rainwater capture? On the linear park, is the purpose to have a real park or is it more aesthetic landscaping? What happens on the linear parks? For Phase 2 and Phase 3, where are the timelines? What are the timelines for when the fees are going to be done or available to the city? Are the seeds being planted coming from C4SM volunteer?

Mayor Delgado opened the public hearing for public comments:

• Les Martin – Thinks the whole plan looks nice. Concerned to have one of those big trees next to someone's home. Happy to see the progress on tearing down the old barracks. Asked if there would be more barracks that need to come down when the Dunes development is complete.

- Mike Owen Happy to support the Planning Commission's approval of the tree removal permits. Spoke about previous tree removals in the development areas and the reactions from the public, staff and from the developer. Spoke about the transplanting of the new trees (saplings) and how they will survive better that the older trees.
- Nancy Amadeo Noted this item is about approving an amendment to the tentative map for phase 2 and phase 3 not about trees. Pleased to see that some things actually went back to the original tentative map.
- Liesbeth Visscher Spoke about the width of the streets and that they can accommodate a firetruck but not the semi-trucks that seem to want to turn down the roads and destroy the landscaping. Commented on the tree removal throughout the project and the expense of transplanting large trees.
- Denise Turley Spoke about faulty water heaters that were installed and asked what was the final outcome of that issue? Commented on the extreme water bills and what was being done with that issue.
- Paula Pelot Spoke about the length of the meeting. Shares concerns about the trees. Believes council members should meet with the City Manager to asked questions about the history of a project so as not to waste time.

Council Questions: The pool and the sports complex itself are older buildings do you have kind of an off-the-cuff idea of if we had started with blank land or undeveloped land, how much of a savings is the existing Pool infrastructure and sports center base, what would the project cost us without the existing facilities? The pavilion that was to accommodate the roller hockey, do you think roller hockey will use it? Will the smaller rooms be properly ventilated to help eliminate respiratory issues such as Covid? Specialized staffing costs? Walking/Jogging track, why is our not elevate? How can we take the existing pool and cut it in two and call both Olympic sizes? Has our school district been able to weigh in on this at all, do they know what plans might be? Will there be some nexus? With the pavilion and concerns for not having an analogous situation with our weather and our climate, might there be some other spillover options for some other type of outdoor activities? Was there a room for staff? Was there an office, or some adequate room for them to take their breaks or alternate meeting sites? Is there a way to use the natural gas that is that is generated over at the at the dump? Is there some renewable source that you've explored at all for the potential whether it's the gas over at the at the dump? Can that be configured into any of this energy usage? Membership pricing structure, are there some opportunities to, for example, off for lower rates for people in a different income category or nonprofits? Is there a mechanism to do some fundraising on this? Outdoor Pavilion, given that this pavilion in every way improves the finances in project, how much would it cost to keep the pavilion design on a par equal to the design of the other 3 buildings? Have you outreach to the hockey leagues or hockey experts in trying to ensure weather safety during the use of the Outdoor Review? Has there been much deliberation on your team for sharing parking to reduce the conflict of parking need with the pavilion shared parking, that is, with the park to the immediate South? If we approve of this motion tonight, and we add on aquatic sender, connector building and pavilion building, so that it's cemented in there then if you design the Pavilion Building right now, but we later decide to locate it across the street and the other park would that entail more money to design it in that way?
