City Council, Successor Agency to Marina Redevelopment Agency Board, Abrams B NPC Board, Preston Park Sustainable Community NPC Board, and Airport Commission: consider adopting Resolution No. 2017-63, 2017-05 (S/A-MRA), 2017-02 (NPC), 2017-02 (PPSC-NPC) and 2017-02 (MAC), adopting Fiscal Year 2017-18 Budget, establishing procedures for amending budget, and authorizing the Finance Director to make necessary accounting and budgetary entries; and consider adopting Resolution No. 2017, 2017 (S/A MRA), 2017 (NPC), 2017 (PPSC-NPC) and 2017 (MAC) authorizing Finance Director to make certain post year end accounting adjustments to FY 2016-17 and FY 2017-18 Budgets.

Finance Director Lai provided a recap of last night's meeting to Council Member O'Connell and Mayor Pro-Temp Brown. Presented the questions you had submitted to us and in addition we addressed the NPS Fund and whether or not we wanted to reimburse the General Fund for those direct costs and whether or not we wanted to appropriate those funds or designate the fund balance. In addition, there were some questions as to council's direction pertaining to June 2016 and whether or not we've followed through with that. Also, there were some questions you submitted Council Member O'Connell and whether or not we wanted to follow up with that.

There is also one new item. The Council asked us to look into the possible payoff of the Pension Obligation Bond, paying it off early and whether or not we would save any interest. It was a question brought up by Council Member O'Connell. We have contacted our fiscal advisor and there is a possibility we could save some interest, we're still formulating those exact dollars. There is a noticing requirement and I would suggest council give us general authority to go ahead and move forward if there is a savings that way we don't have to come back with Council authority and try to meet that 15-day requirement.

Council Questions: on the Pension Bond, what is the sum we would need to pay and where is it coming from; do we take into account any savings or the ability to bring that undesignated balance back up in future years or are we only considering what that would be for this budget year; would staff consider opportunity costs such as if we spent \$250,000 on this early payoff we would have that \$250,000 to do downtown improvements in their analysis; Briefly itemize the other issues that would be worthwhile for council to weigh in on tonight; re-designation of Undesignated Funds/Community Improvement Funds; what mechanism do we have in place to ensure the monies placed in our reserve accounts are not moved and spend on other items; have we funded in this 17-18 budget all the positions that we need to have funded in our city, are we fully funded; is this what the current budget contemplates that is staff does work on the NPS property that the City will be reimbursed;

O'Connell/Morton: to

- (1) <u>Staff bring back to the city council by no later than the second meeting in August the estimated</u> expense of filling all authorized vacant city positions, whether presently funded or unfunded.
- (2) The directors of each city department provide the city council with the modifications to their respective budgets so that the authorized vacant position in their department can be filled and funded in FY 17/18.
- (3) Staff provide the city council with a list of the estimated recurring obligations that it deems are discretionary and are presently not being funded in the proposed FY 17/18 General Fund budget before the city council.
- (4) City manager provide the city council with the benefits and detriments to the FY 17/18 General Fund if a 6 month moratorium on any new projects is enacted.

- (5) Staff look into the payment on the outstanding pension bond indebtedness of approximately \$245,000.00, and proceed with payment in full if it is found to be a financial benefit to the city.
- (6) The proposed General Fund Budget for FY 17/18 be balanced as required by Resolution 2012-
