- 6. - Mike Owen Spoke about Monterey Bay Estates holding their annual Labor Day Parade Pot Luck/Neighborhood Watch; appreciated the Mayor and City Manager for making the Council Chambers available to Supervisor Parker's office to use for public discussion about the homeless on Lapis Road. Asked council if they think they could identify locations and talk about concerns that they city may have and propose solutions; spoke about President Trump's extension/reprieve to the DACA dreamers who are in the country illegally and how it relates to the Lapis Road issue.
- Brian McMinn Announced Public Outreach Meeting on Monday, September 12, 2017 at Vince DiMaggio Park from 6:30-8:00 p.m. discussion will be on the Imjin Parkway Widening Project.
- David Burnett commented on the initial 45-day moratorium that council approved and asked council to reconsider allowing a longer time for the Downtown Moratorium for planning staff to allow them to do the necessary work for the city. Planning is crucial for the development of any city and appreciation for your staff go hand in hand with that.
- Kevin McCallon commented on Lapis Road and the Board of Supervisors voted to extend the time out there for these folks with restrictions. If you go down that road right now you can see that even with restrictions in place they are not being followed. If the city was even to consider bringing them into the city, in to a parking lot thinks that something well open for discussion to the public because if they can't follow the rules as they are now and their previous actions had been detrimental to the environment out there thinks this raises a real concern. Labor Day Parade was great.
- Jack Stewart, Veterans Information Advisory Committee Commented on the lack of signage for the new VA/DoD Clinic and asked if council or staff could assist in placing signage along Freeway and Second Avenue to help those looking for the new clinic; also, commented on the Veterans Cemetery is in need of volunteers for performing maintenance and clean-up. Noted The Marina

Foundation has requested to be notified if there is any unmet needs that can't be satisfied through the normal budget process in The Marina Foundation Veterans Fund.

- Nancy Amadeo, Community Human Services Board Member provided the public with statistical information from the 2017 Monterey County Homeless Census & Survey. January the Homeless Census for Monterey County was conducted over a 10-day period. 10-years ago, the homeless population was 1,402 and today it's 2,837. 74% is unsheltered. There are a lot of reasons why people become homeless. There seems to be a misconception that people are homeless because they are substance abusers or they are mentally ill. In today's numbers that about 36% of the population the rest of them are homeless for other reasons. This summary is a good snapshot to use as we make decisions going forward.
- Seth Morton, Marina Public Safety Officers Association we have entered into negotiations and wanted to address you directly to bring some issue to light. Not including our commanders and our chief we have a total of 24 sworn police officers and 4 of the 24 have applied to neighboring police agencies. That's 1/6th of the department that is seeking employment elsewhere. We have been operating at minimum staffing levels for quite some time. We've had 2 vacant police officer positions for over a year and very few applicants for these positions. We are competing with neighboring agencies who are offering better salaries and benefits. In order to attract more applicants and retain the officers that we do have we have to make the idea of working here for the City of Marina more desirable.
- Rebecca McCallon We haven't had a permanent Chief of Police since Chief Rodriguez left, curious as why the city currently does not have a new Chief and one that would be brought up within our system. Do we promote within ourselves to advance up? We have officer very dedicated to our city and would like to see if we promote up and why we haven't filled this position. Have we filled this position?
- Paula Pelot Announced this Saturday, September 9th from 9:00am-2:00pm is the Annual Community Garage Sale at Preston & Abrams Park. Commented on the social media site Nextdoor and requested that people please do the research/homework on a subject before posting; asked Council if they could prepare a short report that say what our contributed to FORA has been, dollars and cents in terms of development fees, what we've gotten back from that, what we expect to get in the future and whether or not to help citizens as well as people on FORA who are fully engaged with that make some educated decisions about whether or not we support the continuation of FORA and the extension of it.
- Carissa Montez-Alarura brought some concerns to the council regarding rental properties in her neighborhood. What is the capacity of a single-family residential home? Right now, there are 10 individuals living in one home and that number rotates based on the collage class schedules. We battle for parking, peaceful/quiet living. Safety is a concern when raising children in this neighborhood due to the extra vehicles, some going at excessive speeds. Can something be done?
- Mayor Delgado The Labor Day Parade and Festival was very well attended, a lot of volunteer hours went into the event and reflected well on our city, mark your calendar for September 1, 2018 for the 43rd Annual Labor Day Parade & Festival for next year. Thank you to city staff for your participation.
- Mayor Pro-Tem Brown gave a shout-out to Rebecca and Kevin McCallon. On Saturday, September 2nd for the Labor Day Parade the McCallon's park their truck at the end of Crescent and Reservation with two giant fans and a cooler full of water for the anybody. It was a very hot day.

City Manager Long we are still in closed session discussions with council and we are asking that this item be continued to the September 19 City Council meeting.

Public Comments:

Doug Yount – Marina Community Partners and Shae Homes desire that you move forward with the approval of moving forward with the issuance of bond process tonight. Really important that we keep this moving forward, lot of uncertainties in the world and would take a while to go through the Oversight Board, Department of Finance, back to the Council for a final and then the issuance. There's lots of details in there and things that will be forthcoming as those documents are developed. It's important as part of the partnership that exists between the City and Marina Community Partners and Shae Homes as the developer, has had a strong partnership over the years as evidence in the success of the project and we want to continue that partnership on that strong basis and it's always a show of good faith, a show of good partnership when obligations are met in a timely and a good faith method. Issuance of the bonds, the discussions have been ongoing for quite a while now. September 19th would be the 3rd meeting which this would come before the City Council. Thinks it would be very important to move forward tonight. If you're moving forward in discussions on closed sessions or other portions or discussions on the project it would be well received and thinks those discussions would go much better and much more productively if the approval of the resolution in front of you related to starting the process of the bonds would go tonight. That would be very helpful and a good partnership.

a. City Council consider introducing Ordinance No. 2017-, amending Article I of Title 5 of the Marina Municipal Code relating to the business license tax. *Continued from August 18, 2017.*

Lauren Lai, Finance Director recapped the last three council meetings

Council Questions: Section 5.12.070 Residential Rentals – wording makes reference to "it would not require a business license if an occupant rents our rooms" is it your understanding based on the working that exists that in fact if the occupant is not the owner, the owner would have to get a business license for that residence; Section 5.12.080 Real Estate Sales Persons – are you aware that MMC Section 5.04.060 clearly states already and has stated since 1978 "that a person who is considered to be an employee does not have to get a business license", finance director authorized to refund such tax if found to be collected and shouldn't have, you already have that authority; Existing Section 5.16.110 – Penalties was not in the ballot language at all, correct; retro-active of penalties; when were billings sent out for the July 1st filing deadline; did the new ordinance approved by the votes change all of the existing business license sections, were they eliminated or are they still in there; Real Estate Business and Professional Code;

Public Comments:

- Jeff Davi, Real Estate Broker Support first motion, very appropriate to have a carveout for sales people when it comes to real estate matters in a business license tax. You have to be associated with a broker in order to do any business in California, so automatically your broker is covered in those activities; and there is a specific carveout in the business and professions code that states real estate sale people are independent contractors, so you cannot rely on some prior ordinance where all employees are exempt. You simply need a carveout for sales people so there's no confusion.
- Rebecca McCallon commented that real estate agents cannot collect commissions on sales, commission are collected by the Broker and then paid out to the agents. The Broker pays the taxes on the sales. Encourages council to adopt this ordinance amendment.
- Dawn Alva Support motion to approve "as is". Explained to council that the October 1st deadline is perfect because that give her time to do the math and correctly calculate what needs to be paid for her business license as she has already underpaid.
- Paula Pelot Confused on when a Broker pays is paying their business license, when they are collecting a commission are they paying taxes on that? If 7-11's are conducting business individually and they are a part of a larger organization and they're paying this tax not clear where the lines are on this matter.
