Fred Aegerter, Community Development Director – Before you, is an Ad-Hoc Committee for the Downtown Vitalization Specific Plan, which began some years ago. Through a series of events the document was never completed and what we're proposing is an establishment of an Ad-Hoc Committee to assist staff in the preparation of this plan and to move it forward. Staff and council members identified 21 different people who may be interested in terms of participating. We had 11 of 21 people but we have one other person to include on the committee whose name is not listed and that

is Safwat Malek who is an architect working with some of the developers in this area. We anticipate this group being very involved and identifying issues, working to solve issues and resolve them as we move along.

Council Questions: Would Safwat Malek be representing anybody or just listed as citizen; had Horace Mercurio from Coffee Mia been invited to participate?

The State of California, since 1998 has had a Native American Day, which is the fourth Friday of September and does not see any reason to change Columbus Day to a new name.

Council discussed past history on Columbus's arrival and what took place after then.

Mayor Delgado asked if there was any update on the progress of the landscaping on Del Monte/Reservation especially Del Monte and holiday lighting. Also inquired if there was any update on the cannabis issues that might be coming to our agenda anytime.

City Manager Long – No updated information on the Del Monte/Reservation landscaping or holiday lighting. The cannabis issues, we have a deadline by December of this year to make any changes regarding recreational use of marijuana or we lose any ability to do any regulation. The Planning Commission will be considering this item next Thursday, October 26th. The item will be a consideration of a ban on the sales of recreational marijuana only that will then come to the city council. We have met with a firm called Pinnacle Strategy on developing some policy regarding all the other uses of marijuana from cultivation, manufacturing, sale of medical marijuana and we're finalizing a contract with that firm right now. When this recreational item comes to council we'll also be able to give you an update on the timeline.
