City Council open public hearing and take any testimony from the public; and consider adopting Resolution No. 2018-25, forming a Groundwater Sustainability Agency (GSA) and undertake sustainable groundwater management within the portion of the Salinas Valley Groundwater Basin 180/400 foot Aguifer Subbasin with the City and outside the Marina Coast Water District service area, and authorize filing notice of GSA formation with the California Department of Water Resources (DWR) pursuant to Water Code Section 10723.8(a), and authorize and direct the City Manager or his designee to submit notice of adoption of the Resolution in addition to all information required by the Sustainable Groundwater Management Act (SGMA), including but not limited to, all information required by Water Code Section 10723.4 and a list of interested parties as described in Water Code Section 10723.8(a)(4), and authorize the City Manager or his designee to take such other further actions as may be necessary to effectuate the purpose of the resolution, and find that the adoption of the resolution is exempt from the requirements of the California Environmental Quality Act (public resource code section 21000 et seq.) (CEQA) pursuant to section 15061(b)(3) of the CEQA guidelines.

**Groundwater Sustainability Agency Formation:** Sustainable Groundwater Management Act (SGMA) = Local Agency authority for sustainable management groundwater - SGMA Water Code Section 10735.2(a)(1) = Formation of Groundwater Sustainability Agency

The City's area has been revised from what was previously in the council packet. Exhibit A as shown in the packet has additional parcels along the Armstrong Ranch property but in review of the annex agreements with Marina Station and MCWD those areas are within MCWD's GSA area, so those will not be part of the City's GSA. What will be considered is APN's 203-011-001; 203-011-019; 203-011-020; and 203-011-011.



# **Next Steps**

Notice of Intent, 30 days from Council Action; 45 Days from Notice, GSA is formed unless contested within period; Proposing Subsequent Adoption of Ordinance, independent timeline.

Council Questions: Why are we doing this; what's the stance behind or does it overlap where the existing MCWD GSA; what are a couple of the important pros and cons of doing this given it overlaps with the existing SVGSA; Cal-Am letter stating it's "untimely" to do this because it should have been done by June 30, 2017, is there any truth to that?

Mayor Delgado opened the public hearing for public comments:

- Gary Petersen, GM Salinas Valley Basin GSA this is a very complicated issue, this is a new body of law that went into effect January 2015 and there are a lot of people sorting it out and will be sorting it out for a very long time. it's complicated with a finely fine minute details. The GSA that formed in San Louis Obispo is not a GSA because the County that is the GSA in that area declined to relinquish their authority. Spoke with the State yesterday and that was the case that they referenced. The filing of a GSA would create an overlay or an overlap which is a jurisdictional issue that has to be resolved one way or the other, so that would involve the Water Quality Control Board or the California Department of Water Resources who would like us to resolve the overlaps. We worked through that with Marina Coast and we're working through that with a couple of other areas as well. So, we cannot usurp your land use rights with SGMA, important to understand that. We have to work with the existing general plans, we cannot change that. I cannot answer for my board, this happened very fast and we found out Friday because someone saw the public notice in the paper. As far as we know no notices of this action was sent out, certainly we have not received one. I cannot speak for my board this would have to come in front of them before they can make any decisions as whether protest or relinquished. But there is a longer process involved in this that could involve the Department of Water Resources as we move forward. representation for this area when we formed the GSA came through Marina Coast who was the water purveyor, we may have been remised in not including the City of Marina but we are running the two things SGMA requires that absolutely happen with this project, is that it be transparent and based on daily driven scientific decisions. We will be working on that, our process is wide open, we run an advisory group, we can certainly make room for you. We want this to work together and you're free to do as you determine what's in your best interest and then we would just see what goes from that. Happy to answer any questions you might have through the course of this conversation.
- Norm Groot, Exec Dir. Monterey County Farm Bureau & President of Salinas Basin Agricultural Water Association Spent a considerable amount of time, energy, effort and money forming the SVGSA. It took a lot of time to put that agency together. We had a long-facilitated process that lasted over a year to come to an agreement on how we were going to form that GSA. We spent a lot of time trying to be transparent, going before stakeholders and a number of different public

meetings to get the public input and the understanding of what we needed to do in order to form that agency. I don't think that's happened here, since we only found out about this last week through a public notice in a newspaper. There has been no collaboration with anyone else in the Salinas Valley Basin or the overlap that will exist if you do this. I would suggest at this point that you need to do some outreach first before you start moving in this direction. There needs to be some collaboration because when people heard about this it wasn't received very well. I don't think the other thing you've discussed here either is the cost involved in forming a GSA and beyond that developing the Groundwater Sustainability Plan. that could be upwards of \$250,000-\$500,000 in order to do that properly. I don't know if your city council is really willing to spend that type of money on such a small area to develop Groundwater Sustainability Plan. Don't think you can take shortcuts in order to get there. There are specific requirements the State puts forward that you have to have as elements of the plan. as far as discussion about relinquishing authority to this new GSA should that go forward, I think that's going to be a big discussion that the Salinas Valley Basin GSA board of directors is going to have to have at some point in time. I think you should have done the outreach first to them to get the feeling of whether or not that's going to be possible. Now if you move forward and put this in their face so to speak, you'll be putting them in a position where they're going to have to be on the defensive and I don't think that a good position to come from. If you want to be involved in our GSA over in the Salinas Valley Basin I suggest that maybe you participate in our advisory committee, we have a lot of stakeholders that participate in that meeting monthly and that's really where the nuts and bolts of our Groundwater Sustainability Plan are going to be coming before the stakeholders. If you want to become involved our door is open, you can participate there. As far as forming your own GSA I really think you need to take a step back and really decide whether or not that's good for the community and whether or not you're playing nice as being neighbors.

Anthony Lombardo, Attorney - Representing two clients, as the map that was in your staff report indicates two property owners are affected by this, one is the Cemex property and the other is the Armstrong Ranch. I'll eco norm's comment that this process could have been more transparent. Neither of these property owners received any notice from the city that this was coming before the council and it was because some people read the little legal notices in the paper that anyone even found out. That of course leads to a little suspicion over the motive to do this since notifying two land owners that this was coming before the council wouldn't really be that burdensome. I'm pleased the report that as Bob said earlier that as related to the Armstrong Ranch property the mapping was an error and there is no opportunity to for a Groundwater Sustainability Agency on the Armstrong Ranch because the city's boundaries and the Marina Coast Agency are co-terminus within that mustard colored area so that really isn't an issue before you tonight. As to the other piece of property, I say what is transparent is the motive of what can only be the possible motive would be there is no land use possible on that property as know because you participated in this process, the State of California entered into a cease and desist order consent decree with the owners of that property that the property is going to end up as open space in perpetuity at the end of the mining operation, which I believe is in about 3-years. So, there is no land use that's going to occur out there except open space. What is going to occur out there is an application for seawater diversion wells as part of the coastal water project from California American Water Company that does not have anything to do with water supply or the Salinas Valley Groundwater Basin as it relates to the City of Marina that isn't going to be handled by the State Water Resources Control Board, the California Public Utilities Commission and the Salinas Valley Groundwater Agency that Mr. Petersen is involved with. So, not to disagree with Bob but there was a time period within which other agencies had to provide the State a notification that they desire to be a Groundwater Sustainability Agency and that was back in April of last year. Bob also mentioned that it would require the consent of the existing Agency to relinquish this area in order to allow the city to take over the management of it. So, I would suggest as Mr. Groot did that table this matter, reach out to that Agency, find out if that's even a possibility or discuss with the State of California what I think is accurately described by Mr. Rathie and myself that it would require their consent and find out if that's obtainable. Because otherwise it's an exercise in futility to proceed with this any further because the Salinas Valley Agency is the Groundwater Sustainability Agency for this area and will continue to be that until they voluntarily give it up. So, I would appreciate your consideration of tabling this, have your city staff speak to the State, speak to the stakeholders as Mr. Groot suggested and revisit this at a later date because at this point it seems like it's an exercise in futility to proceed further with what we had tonight. I think everybody has a copy of Cal-Am's letter that I sent to Bob so I would hand it out to you again.
