a. City Council consider adopting **Resolution No. 2018-126**, Transportation Agency for Monterey County (TAMC) Regional Development Impact Fee program.

Mike Zeller, Principal Transportation Planner for TAMC: before you is a resolution to update the fee schedule for the Regional Development Impact Fees (RDIF). The RDIF program is a mechanism for new development to mitigate their CEQA impacts to the regional transportation network for any new cars that a new development (housing or commercial) might add. This program was started in 2008

when the cities and the county unanimously approved JPA's to create the RDIF Program and then all the cities in the county adopted the fee by ordinance, so the fees are collected by each of the cities in the county when new development pulls a building permit. The JPA also set up TAMC as the administrator of the program, so we are legally required to update the fees every five (5) years just to make sure the level of the fees are still consistent with the amount of growth that's expected to occur in the county. Within that update process what we do is look at the AMBAG Regional Travel Demand Model to look at what the patterns are now for people in the county, what they're projected to be in the future years 2035 and then we come up with a list of transportation improvements projects to accommodate that new growth in the county based on those travel patterns.

The 2018 update was reviewed by our technical advisory committee and incorporated feedback from this committee and was approved unanimously by our Board of Directors and was reviewed and supported by CalTrans as well.

Council Question: FORA Sunset and incorporation of fees, is there a process or will it be automatic? Traffic funneling through Monterey Road Interchange and Del Monte Blvd Extension will benefit local and not the peninsula, correct? Has FORA paid any Regional Impact Fees to TAMC for development on former Fort Ord? How much money is FORA obligated to provide TAMC over time and in what timeline? If under your new fee you're creating a new "zone" does that reduce the transportation obligation that FORA has on its current CIP?

<u>DELGADO/BROWN: TO ADOPT RESOLUTION NO. 2018-126, TRANSPORTATION AGENCY FOR MONTEREY COUNTY (TAMC) REGIONAL DEVELOPMENT IMPACT FEE PROGRAM, 5-0-0-0 Motion Passes</u>

Public Comments:

- Doug Yount, Marina Community Partners relevant to the TAMC fees and the current FORA CFD fees it would be our interest that any fee levels in the future do not double count in any way. If there's current fees paid to fund FORA CIP obligations those may continue but those also count for the regional fees/regional impact at this point. So, we wouldn't want to be in a situation post FORA where we pay CFD fees and then on top of that pay impact fees to TAMC for regional improvements. In theory the CFD fee covers both.

a. Monterey County Mayor's Association [Mayor Bruce Delgado]

Mayor Delgado – Congressman Jimmy Pennetta attended the Mayor's Association meeting on November 2nd with the other 12 County Mayor's. Congressman Pennetta provided updates on issues such as cannabis at the federal level seeming to be eased from its restricted status; updates on a lot of other things not happening due to division; gave opinions about Nancy Pelosi. This was a well-attended meeting.

b. Council and staff opportunity to ask a question for clarification or make a brief report on his or her own activities as permitted by Government Code Section 54954.2.

Council Member Amadeo announced that she has been receiving messages from PG&E regarding power being turned off in various counties in the Sierra's due to the fires.

City Manager Long — commented about the e-scooter popping up all around town. The city has received a lot of comments on them and our new Assistant City Manager is working internally on this. CSUMB did enter into an agreement with Lime Scooters to provide scooters on their campus and we were not aware of this agreement. Lime did pull a business license in our city, they did it online and we were not aware of them pulling the business license. Matt has me with Lime and have met with some of the other jurisdictions and their agreements and looking at the impacts and one of the good things is that we're actually able to track and see what's going on and able to get a lot of feedback on the positive and negative things on what working. We will be working on possibly an agreement or something to bring back to the council and figure out how we want to address this scooter situation. It involves Vehicle Codes, they aren't allowed on sidewalks, and they don't have any agreement to use our public right-of-way.
