### **Mission Statement**

To implement the role of the Economic Development Commission (EDC) in advising the City Council on specific economic development projects, the EDC has developed goals for the year related to projects such as the downtown revitalization, The Dunes, Arts Village, Veterans Trail, Lock-Paddon Park and the Marina Municipal Airport, among others.

### **Annual Report Background**

Each year, City Commissions are required to submit annual reports to the City Council. The Economic Development Commission, in a collaborative effort with the Economic Development Coordinator has prepared the following report of the Commission's accomplishments in FY 2017-18, as well as their proposed goals for FY 2018-19.

### The City of Marina's Municipal Code

On April 4, 2006, the City Council amended the Marina Municipal Code (M.M.C.) to delete Chapter 2.12 in its entirety and replaced it with a new Chapter 2.12, entitled "Commissions." Section 2.12.020, "Duties and Powers of the Commissions," establishes specific duties and powers, as follows, to the Economic Development Commission: The Economic Development Commission shall be an advisory body to the City Council regarding economic development in the City; downtown revitalization; and ways to encourage business to locate and remain in Marina. (M.C. Sec. 212.020A)

- Accomplishment: On October 2, 2017, collaboration ensued with the Monterey County Arts Council on preparation and submission of a grant application to the National Endowment for Arts-(Chair Alcantara/ Director of Monterey Arts Council Lynch/City staff)
- Accomplishment: Provided comments in connection with the preparation of Request for Proposal (RFP) for a Feasibility Study and Conceptual Plan for the Marina Arts Village-(Chair Alcantara and Commissioner Stetler/City staff)

# Goal 3: Development of an implementation plan for the City's signage, banner, marketing and branding programs; and, engage collaboration with entities such as the Marina Chamber of Commerce in project implementation, subject to City funding.

- Accomplishment: Completed design and installation of three sets of street banners: Joy (holiday); Land-Sea-Air; and Shop-Dine-Stay & Play, which is a component of the Marketing and Branding Program-(Commissioners Lebda/Alva/City staff);
- Accomplishment: Updated the Marina Restaurant Guide-(Commissioner Lebda/City staff)

Goal 4: Continue business site visits to assess the needs of existing Marina based business owners, address needs if appropriate and practicable, and serve as a resource/liaison between them and the City.

• Accomplishment: Completed approximately 40 site visits to restaurant businesses. (Commissioner Lebda/City staff).
