ACCEPTING DONATIONS TOTALING \$6,250 AND ADJUSTING BUDGETS BY
THE SAME AMOUNT TO SUPPORT THE PURPOSES FOR WHICH THE
DONATIONS WERE MADE

WHEREAS, the City of Marina performs certain governmental functions for the citizens of Marina which are appreciated by the community and the larger public; and

WHEREAS, such donations are not subject to taxation as stated in the IRS Code 501 (c) (1); and

WHEREAS, Humble Home Care Services has donated to the City of Marina to support Police activities in the amount of \$2,250; and,

WHEREAS, The Friends of Marina Library has donated to the City of Marina to support Fire Education in the amount of \$500; and

WHEREAS, Marina Community Partners has donated to the City of Marina to support the Marina Labor Day Parade; and

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MARINA DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The City Council accepts these donations.

SECTION 2. The City Council authorizes the Finance Director to increase the operating budgets as follows:

**CITY COUNCIL CONSIDER ADOPTING RESOLUTION NO. 2018-,
ACCEPTING DONATIONS TOTALING \$6,250 TO SUPPORT POLICE,
FIRE AND LABOR DAY PARADE ACTIVITIES AND TO INCREASE
OPERATING BUDGETS APPROPRIATELY**

REQUEST:

It is requested that the City Council:

1. Adopt Resolution No. 2018-, Accepting the following donations:
 - a) \$2,250 from James Collins of Humble Home Care Services to support Police equipment needs;
 - b) \$500 from The Friends of Marina Libraries to support Fire Awareness; and,
 - c) \$3,500 from Marina Community Partners to support the Marina Labor Day Parade.
2. Increase the operating budgets by the following amounts:
 - a) \$2,250 in the Police Department
 - b) \$500 in the Fire Department
 - c) \$3,500 in Non-Departmental Division

BACKGROUND:

The City periodically is given donations to support various City activities. Most donors have an expectation that the funds they give are going to be used for a specific purpose. The proposed action to increase departmental budgets is in recognition of the proposed donations.

ANALYSIS:

The three donations received recently by the City were for specific purposes. The donation to the Police Department occurred because Mr. Collins of New Hampshire knows the Police Chief and wished to support Marina's activities. The Police Chief believes the money would be best served on improving evidence storage.

The Friends of Marina Library wished to have their donation used for public outreach. The funds would support an open house at the Fire Department.

The donation by the Marina Community Partners was given to the City to assist in paying costs for the Labor Day Parade. In the past, these donations would have gone to a non-profit. However, the non-profit was not able to take the donations this year. As a result, the City was asked to receive the donations and pay expenses of the parade for the Non-Departmental Division.

FISCAL IMPACT:

The acceptance of these donations, \$6,250, will assist in improving the community.

CONCLUSION:

This request is submitted for consideration and possible action.
