It is requested that City Council consider:

BACKGROUND:

At the regular meeting of August 16, 2022, the City Council adopted Ordinance 2022-109 directing staff to reconstitute the Tree Committee. From September to October the Deputy City Clerk, Anita Shepard Sharp, sent out recruitment information to Marina residents. On November 21st and December 5th interviews were conducted by the Planning Commission Chair, Vice Chair and the Community Development Director. On January 12, 2022 the Planning Commission reviewed the candidates and recommend that the City Council appoint the following individuals to the Tree Committee for one year terms with two Planning Commissioners, one as a member of the body and the other as an alternate:

If appointed, the Community Development Department will organize a training session with the City Attorney to discuss the Brown Act, recent housing legislation that impacts the review of tree removal permits, annual filings required by the Fair Political Practices Commission (FPPC), and conduct of committee members.
