WHEREAS, the City Park Barracks and Cypress Knolls Buildings Blight Removal 2022 Project includes abatement, proper removal, and disposal of forty-five barracks and miscellaneous debris, including debris from two burnt buildings at the proposed City Park at the Dunes located along Second Avenue and 8th Street (City Park) and thirty duplex buildings and miscellaneous debris including debris from one burnt building, at the Cypress Knoll area along Rendova Avenue and Third Avenue for future park and or residential development; and,

WHEREAS, on August 3, 2022, the City Council passed Resolution No. 2022-101 awarding a construction contract to Unlimited Environmental Inc. (UEI) for the base bid in the amount of \$4,245,000 and approved to expend up to an additional 10% of the contract amount for potential construction contingencies; and,

WHEREAS, the final construction cost is \$4,214,940.20 which includes eight construction change orders due to unforeseen conditions and additional work requested by the City; and,

WHEREAS, the project was substantially completed on May 24, 2023. **Exhibit B** shows the before, during and after construction photos of the project; and,

WHEREAS, on July 19, 2023, the California Department of Toxic Substance Control (DTSC) accepted and concurs with Removal Action Completion Report (RACR) and certified that all appropriate responses have been completed, See **Exhibit C**; and,

WHEREAS, Capital Improvement Projects HSF2101 and HSF2103 have sufficient funds to pay the total project cost of \$5,530,328.88 which includes the construction contract and soft project delivery costs. Approval of this request will result in release of contract payment retention which was budgeted and approved at the time of contract award; and,

WHEREAS, the acceptance of project and authorization to file Notice of Completion for the City Park Barracks and Cypress Knolls Buildings Blight Removal 2022 Project is not a project as defined by the California Environmental Quality Act (CEQA); and,

WHEREAS, the City Park Barracks and Cypress Knolls Buildings Blight Removal 2022 Project is complete. It is appropriate to accept these public improvements and to file a Notice of Completion (**Exhibit A**) for the project with the Monterey County Recorder's Office. Following Council approval, a Notice of Completion will be filed, and contract retention release is 35 days after the recording of the Notice of Completion; and,


That the work under said contract was completed by the contractor or assignee and accepted by the City of Marina on November 7, 2023.

REMOVAL ACTION COMPLETION REPORT AND SITE CERTIFICATION, UNIVERSITY VILLAGES: CYPRESS KNOLL AND CITY PARK (SITE CODE 202420-11), FORMER FORT ORD, MARINA, CALIFORNIA

Dear Mr. McMinn:

The California Department of Toxic Substances Control (DTSC) received the Removal Action Completion Report (RACR) prepared by West Environmental Services and Technology (WEST) in June 2023 on behalf of the City of Marina. The RACR documented the removal activities at the approximately 15-acre City Park (Assessor Parcel Number (APN) 031-221-008-000), and the lack of removal activities necessary at the Cypress Knoll area (portion of APN 031-221-008-000), both located at the former Fort Ord in Marina, California (see enclosure for parcel location map).

At City Park, between January to May 2023, approximately 2,255 tons (1,410 cubic yards) of soil impacted from lead-based paint (LBP) from around 48 former buildings was removed and disposed in an approved landfill, in accordance with the May 2006 Final Removal Action Workplan and August 2022 updated Sampling and Analysis Plan. The confirmation results collected after excavation were used to calculate a 95 percent Upper Confidence Limit (95% UCL) of 36.7 milligrams per kilogram (mg/kg), which is below the site cleanup goal of 80 mg/kg; therefore, the removal action was adequately implemented.

At the Cypress Knoll area, previous sample results were used to calculate a 95% UCL of 35 mg/kg, which is also below the site cleanup goal of 80 mg/kg; therefore, removal action was not necessary for this area.

DTSC concurs with the conclusions in the RACR that the City Park site has been adequately remediated to levels that safely allow for unrestricted land use. DTSC also concurs that the Cypress Knoll area does not require additional remediation based on previous sampling results. The RACR is hereby approved.

DTSC also certifies that all appropriate response actions have been completed, that all acceptable engineering practices were implemented, and that no further removal action is necessary for the City Park and Cypress Knoll area. As with any remediation, if previously unidentified contamination is discovered on the properties, additional assessment, investigation, and/or remediation may be required.

Please note that should this property be considered for the proposed acquisition and/or construction of school properties using state funding, a separate environmental review process in compliance with California Education Code 17210 et seq., will need to be conducted and approved by DTSC. The State also reserves the right to address any appropriate environmental or human health issues should new information concerning the environmental condition of the property become available in the future.

Please notify DTSC if the City of Marina plans to conduct removal actions on any additional parcels.







#### **REQUEST:**

It is requested that the City Council consider Resolution No 2023- for the following actions:

- 1. Accepting the completion of the City Park Barracks and Cypress Knolls Buildings Blight Removal 2022 Project, and;
- 2. Authorizing the filing of a Notice of Completion (**EXHIBIT A**), with the Monterey County Recorder's Office.

#### **BACKGROUND:**

The City Park Barracks and Cypress Knolls Buildings Blight Removal 2022 Project included abatement, proper removal, and disposal of forty-five barracks and miscellaneous debris, including debris from two burnt buildings at the proposed City Park at the Dunes located along Second Avenue and 8th Street (City Park) and thirty duplex buildings and miscellaneous debris including debris from one burnt building, at the Cypress Knoll area along Rendova Avenue and Third Avenue for future park and or residential development.

On August 3, 2022, the City Council passed Resolution No. 2022-101 awarding a construction contract to Unlimited Environmental Inc. (UEI) for the base bid in the amount of \$4,245,000 and approved to expend up to an additional 10% of the contract amount for potential construction contingencies.

#### **ANALYSIS:**

Following is the project expenditure summary:

The final construction cost is \$4,214,940.20 which includes eight construction change orders due to unforeseen conditions and additional work requested by the City. These construction change orders were for additional asbestos abatement and removal of asbestos containing concrete footings, removal and disposal of lead containing soil and installation of perimeter fencing along Rendova Road. Construction change order No. 8 was a deductive change order, reflecting the lower cost for the disposal of lead containing soil.

The project was completed on May 24, 2023. **EXHIBIT B** shows the before, during and after construction photos of the project.

On July 19, 2023, the California Department of Toxic Substance Control (DTSC) accepted and concurs with Removal Action Completion Report (RACR) and certified that all appropriate responses have been completed, See **EXHIBIT C.** 

The City Park Barracks and Cypress Knolls Buildings Blight Removal 2022 Project is complete. It is appropriate to accept these public improvements and to file a Notice of Completion (**EXHIBIT A**) for the project with the Monterey County Recorder's Office. Following Council approval, a Notice of Completion will be filed, and contract retention release is 35 days after the recording of the Notice of Completion.

#### **FISCAL IMPACT:**

Capital Improvement Project funding, HSF2101 for Barracks Blight Removal and HSF2103 and Cypress Knolls Building Removal have original funding amounts of \$4,100,000 and \$1,600,000, respectively. Resolution No. 2022-101 included an allocation and appropriation of additional blight removal funding in the amount of \$415,440 to project HSF2101 and \$161,560 to project HSF2103. The total funding for the City Park Barracks and Cypress Knolls Buildings Blight Removal 2022 Project is \$6,277,000.00.

The total project cost of \$5,530,328.88 is the cost of the construction contract (\$4,214,940.20) and soft costs for project management, engineering and testing, construction management, inspection, and hazardous material fees (\$1,548,642.03). The Capital Improvement Projects HSF2101 and HSF2103 have sufficient funds to pay the total project cost of \$5,530,328.88. Approval of this request will result in release of contract payment retention which was budgeted and approved at the time of contract award.

Funds remaining will be used to pay the California Hazardous Waste Generation and Handling Fee and for the removal of roads, walkways and retaining walls at Dunes City Park and will be included during the construction of Dunes City Park, Phase 1.

The acceptance of project and authorization to file Notice of Completion for the City Park Barracks and Cypress Knolls Buildings Blight Removal 2022 Project is not a project as defined by the California Environmental Quality Act (CEQA).
