a. The City Council to hold discussion and provide direction regarding consideration of potential General Obligation Bond Measure options for constructing new city facilities and potential rehabilitation of existing city facilities.

Police Department Presentation by Police Chief Hopkins

Public Comments:

- Peter Le wished that the Department did the deployment and analysis similar to the fire department. How are you going to convince the property owner to pay for the new police station near Imjin and California Avenue with longer response times? Noted residents already paid for the first police station.
- Robert Dawson Marina is a beautiful place to live and having a better facility to host community meetings would be attractive for possible applicants.
- Mia Nguyen Thanked the police officers for the important work they do. Asked how many
 officers are on the road versus in the office? Has city consider renting space when needed
 for addition desk space? Does city offer our officers discounted or free gym memberships?

City Manager Long provided a presentation on Facility Needs and Assessments.

Public Comments:

- Peter Le Asked will the owners at Sea Haven and the Dunes pay the same tax rate and when do we expect to see the master plan for public building? When do we expect to see the maintenance plan for new buildings?
- John Sanders Marina's relatively modest Community with new growth potential. Commented on the general plan and does not see interaction between the various elements talked about in the general plan. Concerns about moving civic facilities out of central Marina to a distant area. Commented on the PRA he submitted related to RNT.
- Jeff Markham Commented on City Manager's projection about alternatives to the bond, about the increases in utilities and other financial matters. Does not hear council questioning city expenditures and what costs can be cut and what can be sold to make it cost effective. Questioned if Preston and Abrams Park were to be long-term holds for Marina. Bond is fundamentally unfair to the people who bought homes in this area thinking they had city services that have been undervalued under invested in. Asked what is plan B?
- Mia Mguyen Commented on average home value used to determine tax rate. Noted most home being sold are over 1 million. Asked why the numbers were higher 2022 versus 2024? Asked how the tax rates were calculated; what are the projections, are using current Homeowners, current homes that are existing as of now. Noted the economy is uncertain.

RNT Presentation on Community Facility Needs Assessment

Public Comments:

• Peter Le – Submitted 7 written questions to Council and staff and requested review of question and a response by the end of the week I will vote no on whatever option you propose. Stated the council did not listen to the public and did things your own way. The council should go with Option 5 where the people tell you what they can pay.

- John Sanders Commented on his Public Records Request. Commented on General Plan and not seeing City Hall referenced in the document.
- Jeff Markham Asked if an assessment was done on refurbishing existing structures, such as the former fire station on the former Fort Ord?
- Brian McCarthy Speaking as a resident of Marina. Supports putting a larger bond on the ballot for people to decide. Suggests the city be strategic. There is a lot to be done whether a bond passes or not.
