7. COUNCIL AND STAFF ANNOUNCEMENTS:

- Councilmember McAdams Announced the Monterey Bay Aquarium is offering free entry to Monterey County residents for the month of October. Starting September 10^{th,} you can go online and secure your free tickets, you will have to make a reservation and get the tickets online. On Saturday, September 14th at 10:00am is Dad's read at the Marina Library. On Saturday, September 7th is the Marina Foundation's Marina, Man and Woman of the year, this year's recipient Erica Graham, woman of the year, Joey Silver, man of the year, and Mike Mas is getting the Marina lifetime of service award.
- Mayor Delgado Marina High School's JV Football team beat Pacific Grove last Friday night. On September 7th from 9:00am-1:00pm this there will be a 4-H event at the Marina Library where there will be transplanting native plants from small pots to larger pots for planting at the Hilltop Park. On September 8th from 10:00am-Noon will be the monthly Citizens for Sustainable Marina litter pickup starting at Lapis Road.

- Caroline Asked if the cypress trees would cause damage to the streets due to the rooting system.
- Denise Turley Asked if the crosswalk by Jack-N-Box connecting to Locke Paddon Park was part of this project?

The City Council discussed gateway signage and branding, median flagpoles, length of median wall segments, use of local native plants, design funding, traffic flow, roundabouts versus lights, possibility of forming a subcommittee to discuss native plants.

Discussed the stability of salaries and benefits to our general fund, maintenance plans for facilities and infrastructures. Asked to get a 5-year projection. Also discussed the replacement of play equipment at Preston Park and fixing Windy Hill Park play equipment.
