A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARINA
AUTHORIZING STAFF TO PROCEED WITH THE PUBLIC BIDDING PROCESS
FOR THE MARINA MUNICIPAL AIRPORT TAXILANE REHABILITATION
PROJECT

WHEREAS, at a regular meeting of April 6, 2024, the City Council adopted Resolution No. 2024-10, Accepting and authorizing submission of the revised five (5) year Airport Capital Improvement Plan (ACIP) for Federal Aviation Administration (FAA) grant funded airport improvement projects, and;

WHEREAS, City Council approved a grant agreement between City of Marina and Federal Aviation Administration (FAA) for the Airport Improvement Program (AIP) 2023 designated project – Rehabilitate Taxilane – Design Only, in the amount of \$133,200, and;

WHEREAS, authorized application for and acceptance of a State match grant in the amount of \$6,660, and;

WHEREAS, authorized Finance Director to make necessary accounting and budgetary entries as necessary, and;

WHEREAS, authorized City Manager to execute grant application and grant agreement documents, contract documents, and professional services agreement documents on behalf of the City, subject to final review and approval by City Attorney.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Marina does hereby:

1. Authorize staff to proceed with the public bidding process for the Marina Municipal Airport taxilane rehabilitation project.

**CITY COUNCIL CONSIDER ADOPTING RESOLUTION NO. 2025-,

REQUEST:

It is requested that the City Council consider:

1. Adopt Resolution No. 2025-, authorizing staff to proceed with the public bidding process for the Marina Municipal Airport Taxilane Rehabilitation Project.

BACKGROUND:

At a regular meeting of April 6, 2024, the City Council adopted Resolution No. 2024-10, adopting the five (5) year Airport Capital Improvement Plan (ACIP) for Federal Aviation Administration (FAA) grant funded airport improvement projects and the grant agreement between the City of Marina and the Federal Aviation Administration (FAA) for the Airport Improvement Program (AIP) designated project- Rehabilitation Taxilane- Design Only, in the amount of \$133,200 which included a \$6,600 State match grant.

ANALYSIS:

The taxilane represents the only remaining airfield pavement that has not received any rehabilitation effort since the city acquired the airport in 1995. The Airports Pavement Maintenance Management Plan identifies a Pavement Condition Index (PCI) of 66 for this area of the airfield pavement due to numerous pavement distresses such as block cracking, shoving, and surface weathering. The rehabilitation of the taxilane is essential to assure the safe, long-term use and functionality of the element.

FISCAL IMPACT:

A 2.5% match is required from the Airport Fund which is approximately, \$3,330.

CONCLUSION:

This request is submitted for City Council consideration and possible action.
