A RESOLUTION OF CITY COUNCIL OF THE CITY OF MARINA APPROVING A CLARIFICATION ON THE ADOPTED FEE SCHEDULE FOR SIDEWALK REPLACEMENT

WHEREAS, at the regular meeting of July 2, 2024, the City Council adopted Resolution No. 2024-86, receiving the Fee Study Update and adopting the new Master Fee Schedule with an implementation date of September 1, 2024. Included in the fee schedule is Fee Reference S-062 "Sidewalk Inspection". (Exhibit A), and;

WHEREAS, the scope of services for "Sidewalk Inspection" is intended for the installation of new sidewalk including grading, forming, and final finish concrete work. The fee is not intended for the repair of sidewalk due to compliance with City Ordinance Section 8.70.050(c) regarding replacement due to wear and tear and in response to California State Streets and Highways Code Section 5610 which requires the property owner to be responsible for the maintenance and repair of sidewalks in front of their property, and;

WHEREAS, staff proposes to include in the "Description of Service" for S-062 that the cost recovery for replacement of sidewalks due to wear and tear will be "zero", with no charge to the property owner, and;

WHEREAS, the property owner is still required to secure the needed sidewalk repair permit prior to beginning the sidewalk repair work. The impact to the General Fund is anticipated to be less than \$2,000.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Marina does hereby approve a clarification on the adopted fee schedule for sidewalk replacement.
