a. City Council consider receiving an update on the status of an agreement with LimeBike, Inc to allow shared mobility devices to be parked in the City's rights-of-way and to provide staff with further direction. *Continued from May 7, 2019* 

Presented by Matthew Mogensen, Assistant City Manager. It was noted that as of this morning a Bill was going before the state legislator Bill 1286 that's moved its way off the Assembly and now with the Senate. It seems like a Bill written by the industry because what it's really doing is saying the only insurance requirements that the City would be able to ask for is \$1 million per occurrence and \$5 million aggregate, which is not exactly what we're looking at originally. It would also prohibit a city from making a requirement that the shared devise company indemnify the city or the user indemnify the city. it also says that if we were to authorize the use of these things in our rights-of-way we would have to have codified rules and regulations. This Bill would take effect January 1st of next year if passed.

Council Questions: if in fact we authorize this then we have to have rules and regulations? If we executed an agreement similar to the proposed agreement in item 11a that would be authorizing requiring us to have rules and regulations? If Lime has an agreement with CSUMB and we have Lime Scooter throughout the city, but we have no written agreement, we are just in the path of the Lime Scooters are we quote unquote "authorizing it"? Given that you have done so much of the research with regard to this issue as it affects our city including what should or should not be in a contract and including what MBASIA has what we should be considering as our insurance standards, would it be beneficial for our city to write a letter in opposition to this Bill or at least asking for amendment?

- Paula Pelot Do we have the right to remove those scooters that are in the City's right-of-way? Noted that she sees the scooters at people's homes in their backyards. People are collecting them for some reason. They are fallen over on streets and they impede pathways.
- Glenn Mell Only concern is when he see's people zipping by is speed and safety. Not sure if there are any regulations if they have to wear a helmet. It's a two-wheeled scooter and they go pretty fast.

**Project APR 1801 Annual Street Resurfacing Questions**: What does Measure X Debt Service refer to? Will we see the pros and cons of the mathematics behind this later? To fix our streets, what thought

is included here or what plans are included here for rebuilding some of our worst streets? Before we get to the debt funding in a few years, is it potential that we'll rebuild one or two or more of those worst streets every year or are you going to get to that later in this presentation? Are telling people they may have to wait up to 20-years because we're not going to mix any in the meantime? Is the reason why we don't frontload with the bond until FY 20-21 that we have to go to the voters to ask to bond out our Measure X monies or is there a possibility of moving that \$5.7 million expenditure to this upcoming budget year? What happened to the dispute about the General Fund maintenance effort MOE issue with TAMC? If you're putting \$6.1 million in from the General Fund for each of the next six years that would be in addition to potentially bonding and infusing \$5.7 million, correct? In the first year you show a return to the General Fund of \$1 million, what's the negative number? So, the negative number is a payback? \$400,000 Yearly Debt Services for \$5.7 million Bond – Doesn't this figure depend on the interest rates? Have any bond experts been requested for this sort of timing advice?

**Project 1802 - IT Server Room AC Upgrade Questions**: What is shown on the left and right of the slide? If we budget as expected will these pictures change?

**Project 1805 - Glorya Jean Tate, Equestrian Center, Dunes Park Questions**: So, the Pump Track illustrated on the left photo need to wait a little longer until we finish the planning in order to start spending money to build it? So, progress on the Pump Track might start at the same time we finish up the planning for all the parks?

**Project EDR 1808 - Imjin Parkway Widening Project Questions**: When will the construction start? What is the completion date? Is there a total of four round-a-bouts? Didn't TAMC receive a \$19 million grant to help this project out? Where is the other \$16 million coming from? Of the \$35 million how much is it costing the City?

**Project EDF 1810 - City Hall & Annex Permit Center Questions**: Does the current configuration have any effect on moral? Were there any shortcuts or is \$335,000 what was needed? Is accurate to say that when staff is writing a report they have to visit various areas to gather their information for the report? Did you guys investigate how much it would cost to remove City Hall and rebuild it?

**Project EDR 1811 - Del Monte Blvd Extension to 2<sup>nd</sup> Avenue Questions**: If someone what's to ride their bike from the Del Monte Blvd. to the Target Shopping Center when might it be completed?

**Project QLF 1902 - Pool Building Rehabilitation Questions**: Have we spent any on yet on planning? If we built a pool when would it be fully opened, ballpark year? Do we have the money planned for it?

**Project EDR 1903 - 8th Street Extension Questions**: Is this right in front of the Promontory? This is a location for a round-a-bout? Has the University provided input on this proposal? We're talking about from the Target Shopping Center all the way past the Promontory up to Inter-garrison? Has the alignment already been decided by the City? Will the alignment be substantially different than it is today? What kind of Fort Ord recreational trails and greenway considerations have gone into this? So, the FORTAG authors are onboard with this? So, is \$550,000 paying into the construction of the road? So, is \$550,000 just to design the work? How much will this road cost to construct?

#### **Public Comments:**

- Aiden Asked that Council make sure that during development of the Fort Ord property that the Fort Ord Trails remain untouched.
- Paula Pelot Dunes Barracks Stabilization and what the use would be potentially if those buildings other than just historic preservation and as Council Member Urrutia said for tourist or some other use, do we need all six? Preston Park, is \$200,000? The things that would be costly would be the retaining walls, the extension. The repair to the roof, the reason why it gets more expensive is because we're not doing it. These are small areas that need to be re-shingled. The water fountain needs to be fixed. Some painting needs to be done and the capstone. There's no way that's \$200,000. I see money in here for rain gutters at Glorya Jean-Tate. I see money in here for several other park things, some are actual upgrades and some of them are for studies. This mostly is just because it's been allowed to degrade. The outbuilding simply needs to be cleaned out. The dumpster needs to be emptied and a lock needs to be put on there. That's not \$200,000. We're not talking about big improvements. We have events out there that brings money to the city. It has two ball fields and a soccer field. The rest is just maintenance. It's not a \$200,000 project and it's much less than most of the other things you're already allocating for the other parks. Preston Park is a City park, it needs attention and has needed it for some time.
- Mike Owen Sent an email to Edrie before last week's Public Works Commission meeting to tell him his numbers didn't add up on the annual resurfacing project. Those mistakes range from several hundred thousand to over a million dollars. Public Works Commission specifically made the motion at the end of the meeting that the resolution would be forwarded to the Council provided the corrections noted were made. They have not been made. It's the same report that the Public Works Commission received. Old Corporation Yard Entry Gate When I read that the justification for this \$25,000 project was for opening and closing a heavy gate that may lead to staff injuries I was trying to figure out the only way that could happen is if the gate rolled over their foot. Considering all the other heavy equipment public works staff works with this is about as minimum as you can think and thinks that \$25,000 could go much further to further the design of the Dunes project to take into consideration Tatum's Garden coming in at that point. If you look at this specifically you might find other funds that could go towards the Tatum's Garden Dunes project. Hope the resolution takes these notes or correcting into account.

- Nancy Amadeo Several years ago I brought forth the idea of the FORTAG within Marina the Veterans Memorial Trail and that there could be branches off of it. Tonight, was very excited to hear about six buildings being restored on the Dunes Park and whether it is necessary. Appreciated Mayor Pro-Tem Morton's suggestion of stabilization/restoration or can they be duplicated and that is something that should be considered. Thinks it's important in those discussions the FORTAG within Marina being a Veterans Memorial, which you all agreed to. One of the things that made people excited was this gave national purpose to that trail. Now it's not just about connecting us to the National Monument and us to the other communities and visa-versa it was about bringing people into our community because of the historical significance. Thinks it's important three of the barracks should be duplicated. One is an orderly room. One is a Barracks and one is a Mess Hall. Those are the three places that the veterans centered around. When I hear from veterans from around the country who come back here to visit, they're devastated because they can't find anything that relates to when they trained here. I would really like to see that this is incorporated into the park whether it's a restoration project or rebuilding. You've looked at a lot of projects and a lot of dollars are involved. Even if you could do everyone of those projects in the next couple of years you'd have to look at the long-term costs. Every project you do requires continued funding to maintain it and thinks that needs to be part of your discussion.
- Tina Nieto wanted to address that gate over near the gas pumps and the issue that Mike brought up that is would have to roll over their foot. I'm part of the safety committee and we have had an employee injury as a result of that gate and it's not just public works. It's everybody who uses that gas pumps to fuel all the city vehicles. It's not just that it's on a track it's so old and dilapidated that the metal bars that this gate roles on are warped and comes off the track all the time and it's a very heavy gate that there is a potential that somebody could actually be seriously injured. The other concern is from a safety standpoint that we have gas pumps that we don't open and close regularly because of the danger of this gate where that we're not securing them during certain hours and the gate is left open. So, there is safety concern from public safety.

Mayor Delgado – I just need to have some indication if the city council does not wish to continue with the parade, it's truly ok. It's a big effort and it's already behind schedule and so I would rather not wait. We already have two meetings as far as the parade committee. We scheduled another one next week so if the council thinks that this is something we could do without please let me know because I

think it's ok to at least take a break for the year until we figure out what you might want to do if anything for that holiday. I would to hear where you're coming from on this so that maybe we could just wrap it up tonight.

#### **Council Comments:**

Council Member Urrutia - Good to take a break from this this year as more people march in the parade than witness the parade, parade does nothing to honor labor. Marina would be better served by having a Veteran's Day or Memorial Day activity.

Mayor Pro-Tem Morton – Concerned about the cost and to be expended in FY 2018-19 budget, which we did not budget for. Total cost the city if approved is \$20,600 but does not include the absorption of city services. Commented on another organization that volunteered and crated a Veteran's Day at the Equestrian Center, which was heavily attended by our veteran's. See's this as a broader discussion, so to skip the Labor Day Parade in 2019 to have a devotion of public input on what is the event, what would that be and what's really feasible in our budget I think is more appropriate.

Council Member Berkley – What is Labor Day? Our parade hasn't really been honoring workers. Wonders about the money and how it's being spent. Real interest is in seeing cultural diversity occur here and if we were to go ahead with the Labor Day Parade would really like to see a very strong focus on incorporating honor of labor which so many of our community are hard working laborers and should be honored. That we reflect cultural and ethnic diversity as part of the parade.

Mayor Delgado – Mentioned that the city has never paid more than the police, fire and public works costs with a little bit of money for stationary. Normally we spend somewhere between \$3,000-\$6,000 on all the staff the day of the event. This would be adding \$10,000 to the approximate \$3,000-\$6,000 that we spent every year on the parade. We received lots of cultural diversity in our parade. Sounds like we can pull this for this year, so we don't have to bring it back next week.

#### Morton/Berkley: to extend long enough for public comments. 4-0-1(O'Connell)-0

#### **Public Comments:**

- Paula Pelot The math that was presented in Exhibit A does not add up, suggested putting it into a spreadsheet; parades are poorly attended. They may have a lot of participants in the parade, but they're not well attended. We need to think about how we could have a community event that engages the community. Has concerns about the contract. Would like to see the costs associated with each task in the contract.
- Mike Owen –Was impressed at the annual retreat with all the analysis and two-year budget and the CIP, very analytical, logical breakdown of the city government functions and how to make them more efficient. There is no CIP (Celebration Improvement Plan) for Labor Day Parade. What the Mayor expressed at the last meeting was a disappointment because there wasn't any improvement in business because of downtown participation. It seemed like there were a lot more people in the parade that were from outside Marina, not in Marina. What's the purpose of the parade? Is it to try and bring more business to downtown Marina? Has an analysis been done for past parades? How many people were in the parade? How many Marina organizations were in the parade? What was the expense that the police and public works had to do as a quantitative figure besides just the \$10,000 that's budgeted? I think this is a good opportunity to maybe not abandon it but try to do some sort of quantitative analysis or logical planning or structure for what it is that you want to happen. Whether it's a Labor Day, Memorial or whatever or if it's a parade or the equestrian center. Need some sort of measurement to see if you make the goal or some sort of plan that's similar to like everything else that you do with the government.

e. Mayor Pro-Tem Morton – staff recommendation is to instead of having to have this come back to Council every year to set the surcharge at 7% for 2019 and every year after that. My Question is: that the surcharge at 7%, that's the cap that we can currently do under the ordinance we adopted but its only recovering 91% of the cost for services. What is the procedure for increasing the cap to 8% or 9%? And even if that can't be done for 2019 that we start that procedure for 2020 and each year thereafter. So, the concept when we adopted that ordinance we set a cap that we thought we'd recoup 100%, now that's not happening. So, we would not be able to amend our ordinance between now and the time this needs to be set for this 4<sup>th</sup> of July?

MORTON/URRUTIA: THAT WE SET THE SURCHARGE AT SEVEN PERCENT (7%) FOR THE CALENDAR YEAR 2019 PURSUANT TO MARINA MUNICIPAL CODE SECTION 15.32.091 AND EACH YEAR THEREAFTER WITH THE DIRECTION THAT THAT MUNICIPAL CODE SECTION BE BROUGHT FORTH IN FRONT OF COUNCIL FOR MODIFICATION TO INCREASE THE AMOUNT TO ENABLE THE CITY TO RECOUP THEIR EXPENSES. 4-0-1(O'Connell)-0 Motion Passes
