Mayor Pro-Tem Morton – Pg. 2 states that city staff advertised the project at \$1.2 million and total cost of the project is \$1.797 million. What the modification to the long-term plan and how does that impact staying on target to keep our roads at 70%? Is it appropriate to go forward with this contract without looking at potential modifications, so that we make sure we're getting the roads that we want to do over the next five years? Are you recommending that we expend the monies for this even though it's over the budgeted amount for this particular year and that you in November would come back as a review at as to what if any changes we need to look at in adjusting the budgeted amounts for the balance of this year and in future years?

Council Questions: Does it have a dollar for dollar impact that is \$324,000 of planned work that can't happen somewhere else because of this need? What does the leftover/carry over already planned to be part of this year's expenses?

Cody Phillips, Lombardo & Associations representing CalAm – Submitted letter this afternoon and provide copies with attachments to the Clerk and Attorney for review. We request that Mayor Delgado, Council Member Berkley and Council Member Morton recuse themselves from this item which directly implicates their long-standing biased against CalAm's Monterey Peninsula Water Supply Project. CalAm has submitted substantial evidence of bias on part of these decision makers which prevents them from fairly and impartially making decisions that would impact the project. We would ask that the city refrain from taking action because the city has demonstrated institutional biased against CalAm's project and the city's actions are improper under the Sustainable Groundwater Management Act and State law. The city's attempt in creating its own GSP exclusively for the Cemex site is legally and procedurally improper and is a blatant attempt to halt this much needed project. Therefore, we would ask that you refrain from taking action this evening. Thank you for your time.

Mayor Pro-Tem Morton – Cost increase - How did we miss the significant increases between December 2018 and now? Do we have adequate funds? What do we do if we have to pay \$105,000 more than what we budgeted? Is there enough activity during the day to warrant nighttime work on the runway?

Council Questions – Reference in staff report of August 6<sup>th</sup> deadline date, is there a problem with this now being August 20<sup>th</sup>? And there is still no problem with the federal government and the grant and the marijuana ordinance that we have? This extension of the taxiway, what affect if any does it have the likelihood of us being successful of getting grant money for extending the runway?

Council Member O'Connell: In years past, prior to you getting involved, the relationship with the FAA was not as beautiful as it is now. I think this Council needs to realize the effort and work Jeff is doing out there pretty much on his own except for the maintenance person who is helping you. I truly appreciate the fact that the airport is coming around and being successful. On behalf of the Council thank you very much.
