## **REQUEST:** City Council consider:

1. adopting Resolution 2019- authorizing the City Manager to place on a future agenda for discussion and decision the enactment of a policy permitting Marina residents, who are registered voters, to occupy an absent council member's seat for the sole purpose of asking questions and making comments on open session agenda items.

## **BACKGROUND:**

The last two elections for city council positions have been unopposed. Public attendance at commission and city council meetings has been, at best, minimal. There is a tremendous need for public involvement in local matters. Decisions are made at these meetings and very little input is received from the public.

## **ANALYSIS**:

In an attempt to get more members of the public involved in their city's matters, I am asking the City Council to place on a future agenda an item that addresses the question of more public involvement in city discussions and decisions. I am suggesting the following criteria:

- 1. Must be a registered voter and resident of the City of Marina.
- 2. Will only participate in Open Session agenda items.
- 3. Permitted to ask questions and make comments on agenda items.
- 4. Will not be allowed to vote on any item.
- 5. The Council member who will be absent must designate the individual who will occupy his/her seat at least one week before the meeting. In the alternative, the city clerk may establish a voter list of persons who desire to participate in the policy/process.
- 6. If the Mayor is absent: the person chosen will sit in the council seat of the Mayor Protem who will preside over the meeting.
- 7. If the Mayor Pro tem is absent: the person designated by her shall sit as a guest "council member" and, if necessary, the City Council may appoint a temporary MPT for that meeting only.
- 8. If two council members are absent: the designated persons shall serve as guest "council members" and not as Mayor or MPT.
