- Marilyn Lidyoff, Marina Economic Development Coordinator Announced to the Council and public that she is retiring from the City on October 31.
- Tina Walsh Our sole source of water is being threatened by the actions of the Cal-Am Corporation who is working to build a project partially within our boundaries that would extract our groundwater in massive amounts and desalinate it for their own use to sell to their ratepayers on the Monterey Peninsula. Marina will not get one drop of this water and our water source will become more contaminated by saltwater from the ocean and our beautiful shoreline will be permanently damaged. Only two-years ago agreements we made to close the Cemex Sand Mining Plant in 2020, restore its site to its natural condition and allow for increase coastal access. Instead, if the Cal-Am proposal succeeds we would be left with another industrial facility on this very same site. There is a chance to stop this Cal-Am proposal. On November 14th the California Coastal Commission development permit hearing in Halfmoon Bay. The goal of Just Water is for every Marina and Ord community resident to attend this hearing to let our voices be heard. This Cal-Am project is unfair, unnecessary and uninvited. It is unnecessary because there is a recycled water project called the Pure Monterey Water Expansion Project that can provide the peninsula all the water they need. Please help us to protect our water and the future welfare our city.

What is considered "multiple listing"? is an Accessory Dwelling Unit (ADU) considered to be part of the primary residence or a separate residence? Would we consider adding a limitation on the number of nights that you could do a homeshare? Does this ordinance allow persons renting a home or apartment to do short-term rentals?

a. Monterey County Mayor's Association [Mayor Bruce Delgado]

Mayor Delgado, the next Mayor's Association will be meeting on Friday, November 1st here in Marina at Evelin's Restaurant, next to Coffee Mia's.

b. Council and staff opportunity to ask a question for clarification or make a brief report on his or her own activities as permitted by Government Code Section 54954.2.

City Manager Long, announced tomorrow we will be having the open house for our districting over at the Library from 4:00-8:00PM and October 22nd is the last day for submitting maps; a special meeting on October 29th to discuss the GSP and get further comments; there will be a special Joint City Council and Planning Commission meeting on November 12th to provide an update on new housing laws for the state; due to conflict with council calendars was are unable to schedule our retreat in November. We're looking at possibly January 24-25, 2020. We would still be sending out an updated work plan on all of our items and where we are to date in November. Joby Aero Update – they will be submitting an application next Friday for their larger building. We still don't have a lease in place with them, but we can move forward with the application process without the lease. Next steps are for our attorney to get together and go through lease modifications.

Dan Paolini, Chief Building Official, update on Marina Airport Restaurant – Received final design from our architect. Going to use a process to avoid public bidding by contracting with sole source which uses a typical rate of construction based on today's costs. In negotiations with Gordian and also with a contractor to come up with the final scope of work. Looking to bring final proposal to Council for approval sometime in November. Joby Aero Update – Joby is very invested. They lease about half of Hanger 507 and lease the entire Hangar 527. They are not manufacturing anything yet but in the process of setting up equipment. They have TI permit for 527 for two phases of construction. In 507 they have another TI permit that is in plan check for taking half of that building for manufacturing.

Mayor Delgado, on November 14th at 9:00am in Halfmoon Bay is the California Coastal Commission 2-day meeting on Cal-Am appeal of City's Planning Commission denial of their coast development permit.
