Robert Rathie, Assistant City Attorney reported out Closed Session: the Council opened the meeting earlier at 5:00pm prior to the Closed Session and established a quorum with Council Member Urrutia opening the meeting and everyone else on a teleconference call in accordance with the relaxation of the Brown Act requirements by Governor Newsome's recent proclamation. Council then met in Closed Session on the matters listed on the agenda. Received information, provided direction and no reportable action was taken. - Mike Owen – Can more information be provided about the relaxation of the Brown Act? This morning Governor Cuomo was arguing against sheltering in place in the San Francisco Bay area and he described sheltering in place as go inside lock the door and throw away the key. At first glance some people may think of it that way, but you don't have to. You can go out and walk your dog, walk along the beach etc. There are plenty of activities where you can social distance yourself from others and be safe.
- Cristina Medina Dirksen – thanked Council in this confusing time that our city has a piece of mind to meet and take care of its residents. Pointed out that they have a Block Captain System so for people watching check in with your Block Captain if you have one and there is a Facebook page called Marina Community that people can access for needs. Marina Grocery Outlet is collecting at the register for families who might need gift cards, the community is urged to donate if you can. Gift cards will be pushed out to our school district and our community and our hotel workers. The Community Foundation for Monterey County has the COVID relief fund that will be pushing out money to non-profits working in the sector of providing basic services.
- Council Member Berkley – PG&E has a moratorium on service disconnection for nonpayment effective immediately. This will apply to residential and commercial customers and will remain in affect until further notice. For more information you can go to: www.pge.com/covid19 . Mentioned that MCWD discussed how to help customers. A request was made for MCWD to not do shut offs and to also allow for longer payment plans. If you have animal and find yourself in crisis with your animals and facing financial hardship you can go to the ASPCA or other animal

shelters for extra food, but please call ahead of time. If you're able to make donation to the ASPCA or shelter it would be greatly appreciated. If you are sheltered in place/quarantined with an abuser and are worried about having to self-isolate in a dangerous home situation you can reach out through any of the social media @ndvh or call the National Domestic Violence hotline at 1-800-799-7233 or TTY 1-800-787-3224; and you can chat@thehotline.org

- Council Member Urrutia – For anyone experiencing temporary layoff or furlough or a loss in hours as a result of the corona virus outbreak there is a really easy to access list of resources from the state at www.labor.ca.gov/cornoavirus2019 you could see answers to your questions. If you are lucky enough to be part of a union, you should reach out to your union for valuable resources. Advised everybody to look at the State's department of labor website to see how you can make yourself whole if you have any loss in pay and check in with your union to make sure your rights as a worker are protected.
- Mayor Delgado – Read a prepared comment on COVID-19 worldwide. COVID-19 has rapidly changes our lives and will continue to do so. Governments have responded so that those that become sick can be treated by our healthcare system. If we don't slow this illness people who could be cared for could die. For most people we will be fine but by reducing our activity to essential activities we are all helping our neighbors who may be at risk. By practicing social distancing such as staying away from non-household members by 6 feet or more, reducing our interactions except for essential activities we will save lives. During this time the City has closed recreation programs, but the city will continue to operate. Public hours will be more limited and or on an appointment basis, but our fire department will respond to our calls and the police will continue patrolling our community. The County health officer as of today has issued a Shelter in Place order, which many of you already know and becomes effective at midnight tonight. The order is similar to ones issued by six other Bay Area counties. All of these orders are similar in that they limit our activity, travel and business functions to only the most essential needs, essential businesses and operations shall remain open. This order does not affect essential government services, which are here to protect us, our health, our safety and our welfare. The goal in all of this it to limit groups congregating together to stop the further spread of the virus. It's not a complete social shutdown, it means stay in your home and don't leave unless necessary for one of the designated exceptions. But of course, you can leave your home for specified reasons to make sure you have what you need for life, such as food and medical supplies. You're also allowed to go outside, take care of pets, go on a walk and just get outside. So as long as you don't congregate in a group and maintain at least 6-feet of distance between you and other people you can do your part by following the directive given to us by the Monterey County Health Officer and we will keep you updated on our website: www.cityofmarina.org sharing what information we have. Although it's natural for all of us to feel concern the city has survived earthquakes and other challenges in the past and we will do so again. Thanked everyone in the community for coming together and doing what we can to help one another.

Council Member O'Connell: Page 4, Table 3 – would the depreciation of the vehicle be considered to address the total cost of the vehicle if it were to be purchased? Why is there no column for gas/fuel? Are we paying the residual of the vehicle after we've paid the lease? In a personal lease that person pays for miles upfront, is that same here? In automobile set-a-side account, how do we account for that in the lease process? Are we putting additional monies into the automobile replacement fund to account for the purchase/lease price at the end of the lease? Is the lease pricing coming out of the vehicle fund or out of the general fund? Is there any difference in the insurance coverage expense for a leased vehicle compared to what we own?

Council Questions: What is the recommended amount that we have in our reserve, it's a percentage right? What percent do we put into our emergency reserve fund? Page 6 of the staff report it referred to the tax increment payment to Marina Community Partners, how much money is owed? Same page, it is mentioned \$900k in land assets currently used for ponding basin around the city, what would determine turning our perc-pond into affordable housing? Have you heard any State gestimations or projections about the impact of COVID-19 on the financial stability of cities? should we start looking at where we need to be cutting expenses or anything like that? Page 15, the population shows an increase of about 500 from January 2018 to January 2019, is this a reflection of not very many more people (500) but several new million dollars in taxes? Is that an indication that those increases are not coming from our residential population? Is it true that because we're more dependent more on sales and hotel tax revenue than we used to be that we're more vulnerable in an economic downturn? Since we have \$4.6 million in emergency reserve and another \$7.5 million of unallocated monies that we may need to dip into that severely if we have an economic downturn? If we do have an economic downturn is it your estimate that we'll do fine because of our \$12 million essentially combined reserve? Would it be sensible to consider what the city might do to spend \$30,000 to help businesses or residents with short-term loans or loans that you know will not be paid back or some other support to the city residents? Are you comfortable with the number of employees in the finance department or are you looking at additional employees? Recreation Accountability of Timecards – where are we on the process of time keeping other than New World Systems? Do you see this being a problem for future audits?

Public Comments:

- Cristina Medina Dirksen – wanted to commend the residents of Marina who voted for the half-cent sales tax as it seems to have put us in a strong position. Short-term loans would help out community. Thank you to the finance department for the diligence in this report and look forward hearing it and seeing where were.
- b. City Council consider adopting **Resolution No. 2020-29**, ratifying a Proclamation of a Local Emergency by City of Marina City Manager Related to Covid-19 (Coronavirus), and discussion and update of current situation and provide staff further direction.

Council Question: how many road projects will be cancelled or are they considered health and safety economically beneficial and will continue? Is everything so far just continuing with the bids/work being done on our streets or has there been a pause? So, the actual road maintenance crews, would they require any change orders in their contracts with the city if safe distancing is causing them to do work slower? So, so far there's no slowdown in actual street work getting done due to COVID-19? Citizen oversight of Emergency Counsel, would entering into contract include employment contracts with our bargaining units? Would employing temporary workers still be subject to meet and confer with city bargaining units? Would this override current contracts with other agencies? When it comes time to make a motion would the council maybe entertain changing the time period that this declaration would run? Page 3 of the original staff report, top of the page "*Be It Further Resolved formalities required by the city by ordinance or other regulations shall be waived where strict hinder or delay the mitigation effect of the emergency*" is that language included in the revised resolution? Is the city doing anything to clean the playground equipment and the things touched by the public?

The City Manager in his role as the Emergency Services Director directed that due to the COVID-19 pandemic that all non-essential Boards and Commission will cease to operate. The Council and Planning Commission to continue operations and their focus to be on the central public health and safety issues.

Berkley/Morton: to approve the revised Resolution No. 2020-29, ratifying a proclamation of a local emergency by city of Marina City Manager related to COVID-19 (coronavirus).

Public Comments:

- Mike Owen – Commented about receiving an email from CDD about the Planning Commission reviewing the elimination of 50 trees along CDAC Hill without going through the tree committee because the tree committee didn't exist in 2005, which was puzzling because he attended all the Tree Committee meetings in 2005. Not as confident about this provision being abused because I see the Planning Commission is still having meetings and as far as I know the staff has not responded to the emails that I have forwarded to you saying that the Tree Committee didn't exist in 2005 and if they continue to go to the Planning Commission and they pass this then I'm asking to appeal it to the Council. Wondered if the process for appealing is like one of the items that is no longer available with this motion. A year ago, there was talk about doing away with the DRB and Tree Committee. Not really confident about these sub-committees being reactivated after this emergency process goes through. Has no objection as long as a stay in place measure continues with just having a consent approval by council to continue this emergency council nut once that period gets over where it's no longer stay in place I really hope that when it comes back to council it's actually a discussion and not just a consent item. If we're going to have reduced council

meetings and public input and there's only room for 10-people that possibly you'll consider allowing more than four minutes for public comment during this emergency situation.

- Cristina Medina Dirksen – Concerned about this council because in the spirit of transparency I think people want answers, they want to know what's going on. I know it's on the website but hopes there would be a little bit more input from the public and if people have questions who should they direct them too? I think barricades need to happen or something at our parks because having kids at a park is like being in a candy store and can't eat candy. That has a potential to cause problems and who's going to police the parks? What will happen if people are seen on the playground equipment? Use of city facilities, what plan is in place to offer use a city facility for distribution centers, or even public use if there's some ability to babysit kids? Thinks there need to be more information pushed out. What resources are you using to communicate? Are you all talking on NextDoor? Are you doing Hustle? I would be happy to be point person as my role as a block captain and as community organizers we have access to volunteers, phone lists, email lists and urge you to push information out to the public because we want and need to know.

Council Member Urrutia wondered if the maker of the motion would consider as a friendly amendment include *“that at each regularly scheduled Council meeting the City Manager provide us a list of the actions the Emergency Council took under the emergency powers”* that we're granting them just so that as members of the Council also the public could sort of know what's changes if anything.

Council Member Berkley and Mayor Pro-Tem Morton accepted that friendly amendment.

Council Member Berkley: Would like to consider place an urgency ordinance on a future agenda to protect renters from evictions or rent increases for those how have adversely been affected by the loss of work or income due to COVID-19. 50% of our residents works within the hospitality and tourism business and 60% are renters who live paycheck to paycheck. In our city we have 127 children who qualify for assistance under the McKinley-Vento Education for Homeless Children and Youth Program. Thinks we should see how we can help our residents. Other areas that I'm looking at how we can help is perhaps through GreenWaste or the local Cable TV. Concerned about business licenses

and the suspension and or extensions of payment or payment plans for city permits and license. Thinking maybe for a period of six (6) months that we put this in place and that it be retroactive from March 1st.

Council Questions: Is there added value by the city doing something similar to what the County did today on prohibitions evictions and rent increase? If everyone protected under the County's Emergency Order from evictions or rent increases due to COVID-19? Is there a timeframe on that (County's Emergency Order)? How quickly can we get something in place? Would we need a separate ordinance to deal with city permits and such for small businesses?

Berkley/Urrutia: To direct city attorney to work with myself (Lisa Berkley) to review and write a draft ordinance to bring back to council.

Amended Motion:

BERKLEY/URRUTIA: TO ESTABLISH AN AD-HOC COMMITTEE OF TWO PEOPLE, MYSELF AND COUNCIL MEMBER URRUTIA TO WORK WITH THE CITY ATTORNEY TO BRING BACK AN URGENCY ORDINANCE AS SOON AS HUMANLY POSSIBLE TO ADDRESS RENT INCREASE, AND EVICTIONS IN THE CITY OF MARINA AS WELL AS LOOKING INTO BUSINESS LICENSE FEES OR OTHER PUBLIC SERVICES TO HELP THOSE ECONOMICALLY HURT; AND MONITOR AND COORDINATE WITH THE EFFORTS OF THE COUNTY AND STATE; AND HAVE THE OPPORTUNITY TO BRING IN EXTERNAL COUNSEL. 5-0-0-0 Motion Passes by Roll Call Vote

Public Comments:

- Cristina Medina Dirksen – Commented that establishing what businesses, also take into effect that you have businesses that have high sales that might be taking a hit later on with whatever happens to their business in terms of them hitting a larger point but may have sustained loses later on with their employees or things outside their control.

The Mayor's Association met in Sand City last month.

- b. Council and staff opportunity to ask a question for clarification or make a brief report on his or her own activities as permitted by Government Code Section 54954.2.

Council Member O'Connell – MST Board with the cooperation of MPC Board were able to pass a free-pass for MPC students anywhere in the County, all they have to do is show a student ID.

Mayor Delgado – Marina Earth Day event is cancelled; Famers Market will remain open on Sunday's because it's considered an essential business offering food.
