# APPLICATION REQUIREMENTS FOR LOT MERGER

**Lot Merger (Revision to Acreage):** Review of a request to revert multiple lots to one lot under the terms of the Subdivision Map Act.

#### **APPLICATION REQUIREMENTS:**

- Planning Application Cover page.
- Required application fee.
- Affidavit
- Signed and Notarized Lot Merger Notice form
- Current preliminary title report(s) for affected parcels
- Copies of latest grant deeds for the existing parcels
- Proposed legal descriptions
- □ Plot Plan: A reproducible Plot Plan map (maximum size 11" x 17") drawn to a legible scale that illustrates the lot merger. The Plot Plan must illustrate the following items where applicable: (a) existing and proposed lot areas; (b) existing surface and subsurface structures and improvements; (c) existing septic system and well locations; (d) streams and waterways; (e) existing/proposed easements and access routes; and (f) any unusual topographic features or other information (such as compliance with minimum setback requirements) that may be pertinent to review and approval of the application:
- □ **Plot Plan** to include:
  - Applicant, owner, and plan preparers name, address, and phone number.
  - Vicinity map showing an overview of the project location in Marina.
  - North Arrow and Scale.
  - Address and Assessor's Parcel Number (s) of the project site.
  - □ Two (2) foot contour lines
  - Property lines and dimensions of the site and surrounding properties.
  - Adjacent rights-of-way improvements, including utility poles, fire hydrants, meter boxes, plan lines, and center street medians and openings.
  - Outline and identify use of structures on adjacent properties within 25 feet of subject property.
  - □ Existing structures, parking areas, driveways, patios, stairs, decks, fences, walls, etc.
  - Existing and proposed easements.
  - Proposed buildings and intended uses.

Note: All checked items must be included in the application in order for it to be deemed complete. Failure to include the requested items may result in a delay of the application process.
